SUBJECT: Fiscal Year 2023 Community Development Block Grant (CDBG) Allocations for the Capital Improvements Program (CIP)

Thank you for the opportunity to provide input regarding CDBG funds to be allocated toward projects in the Capital Improvements Program. The CDBG program continues to serve as an important funding source for the City of San Diego to introduce infrastructure improvements in low- and moderate-income areas. These historically underserved neighborhoods deserve high-quality parks and recreation facilities, libraries; as well as upgrades to their sidewalks, streetlights and bike lanes; to the same extent as other parts of San Diego. I am proud to stand alongside the Mayor and my Council colleagues in our commitment to equitable and intentional infrastructure upgrades that will help make up for decades of under-investments in these communities.

In Fiscal Year 2023, I propose the following CIP projects be considered to receive CDBG funding:

- San Carlos Library (S00800)
- Linda Vista Community Center, to be built at the corner of Comstock Street and Linda Vista Road
- Alvarado Canyon Road Realignment (P18007)
- Kelly Street Neighborhood Park (P22004, GDP only)
- Linda Vista Library Outdoor Patio Expansion
- John Baca Park (P19003, GDP only)

- Linda Vista Community Park improvements, including:
 - Resurfacing of tennis courts and installation of windscreens
 - Replacement of outdoor security cameras
 - Resurfacing, striping and introduction of signage at parking lot
 - Installation of perimeter wall of the outdoor basketball/multipurpose court
- Mission Valley West Valley Crossing, bridge connection between Sefton Field and the Mission Valley YMCA
- Unfunded projects for CIP Annual Allocations:
 - Installation of continental crosswalk at the intersection of Sandrock Road and Palm Ave
 - Median improvements along 3290-3395 Sandrock Road
 - Left turn signal at Riverdale Street/Friars Road
 - V-Calm sign on Kelly Street
 - Installation of sidewalk on north side of Friars Road, between River Run Drive and Qualcomm Way
 - Installation of/upgrades to bike lanes along Friars Road and Linda Vista Road
 - Installation of streetlights along:
 - 2600 block of Nye Street
 - 6200 block of Osler Street
 - 6300 block of Inman Street
 - Camino Costanero, between Via Las Cumbres and Camino Copete
 - Camino Copete, between Caminito Juanico and Caminito Salado
