North Park Planning Committee Special Election Voter Guide

July 19, 2022

The North Park Planning Committee is holding a special election to fill four recently vacated seats. NOTE: Voters no longer have the requirement to have attended a NPPC meeting in the last year. However, candidates running for a seat must have attended at least one NPPC meeting since July 2021. North Park Planning area boundaries can be found on page 15 of the [North Park Community Plan](#).

CANDIDATES REQUIREMENTS (PER [NPPC BYLAWS](#)):

1. Either live within the North Park boundaries or own a business or property within the North Park Boundaries.
2. Attend at least one NPPC meeting between July 2021 and June 2022.
3. Must submit their interest of candidacy, with below information by **Friday, June 24, 2022, 6:30PM**.
4. Submit the following information to info@northparkplanning.org:
 - a. Name, address, phone number and email, (if available)
 - b. Photo ID (i.e., driver's license)
 - c. Proof of North Park residency, business ownership. or property ownership (i.e. utility bill)
 - d. Date of at least one NPPC meeting you attended (sign-in online) from July 2021.
 - e. Candidate statements are encouraged, but not required.

ELECTION DATES & LOCATION: North Park Mini Park, 3812 29th Street:

- Friday, July 15th from 5:00 PM to 8:00 PM**
- Sunday, July 17 from 10:00 AM to 1:00PM**
- Tuesday, July 19 from 4:00 PM to 6:00 PM**

NO ONLINE VOTING FOR THIS SPECIAL ELECTION. REGISTER AND VOTE IN PERSON.

IN PERSON VOTING REQUIREMENTS:

1. Name, address, phone number, email (if available)
2. Voters must prove eligibility to vote in NPPC election—renters, owners, and people who currently own property or businesses in North Park, whether they live here or not.
3. Voters must confirm their identity by presenting a government issued photo ID – required of all voters. If the address on the photo ID is not a North Park address, then a current utilities bill, tax bill or other proof of current address – a copy of a current lease, for example, is required.
4. Write in Candidates are allowed, and must qualify per candidate voting requirements.

Election results will be announced at the July 19th, 2022 North Park Planning Committee meeting

- Each voter is assigned a numbered ballot to vote at that time. The unique number can be torn off and kept by voter and the rest of the ballot will be placed anonymously in the ballot box and secured.
- Current Covid-19 protocols related to mask wearing and social distancing will be posted at the in-person voting location.
- Electioneering is prohibited within 500 feet of the polling locations.
- In-person voting location is accessible for people with disabilities.
- Proxy voting (voting for someone else) is not permitted.**
