COURT UPHOLDS CITY'S RIGHT TO RESTRICT POT DISPENSARIES

JUDGE: LOCAL ZONING LAWS NOT TRUMPED BY PROP. 215

San Diego, **CA**: Superior Court Judge Ronald Prager has issued a written decision (attached) holding that the City of San Diego's zoning laws are not preempted by state laws that allow for the use of medical marijuana.

Under the decision, Judge Prager ordered closed the Ocean Beach Wellness Center at 4851 Newport Avenue. The business was ordered to cease operation by 5 p.m. Thursday, Oct. 13, 2011. Earlier in the week, the judge issued a Temporary Restraining Order requiring the Redwood Collective at 1516 W. Redwood St. near downtown to close as of Oct. 11, 2011.

In addition to 12 cases filed earlier this month in which closure orders were obtained, the City Attorney's Office this week filed new civil cases against 16 more dispensaries that are operating in violation of City zoning laws. The office expects to file another group of cases next week.

"Our job is to enforce the law as to dispensaries operating illegally in the City of San Diego," said City Attorney Jan Goldsmith. "We are also willing to work out settlements with those building owners who are committed to voluntarily removing illegal drug operations from their buildings."

Prager wrote in a decision handed down Thursday that the City had a right to regulate and restrict the location and establishment of marijuana dispensaries based on local zoning law.

The judge emphasized that state law regarding medical marijuana is narrow in scope and addresses only the cultivation and possession of the drug for medicinal purposes.

"(State law) does not address the licensing or location of medical marijuana dispensaries, nor does it prohibit local regulations of such dispensaries," Prager wrote.
