In response to the recent CityGate report, a mapping model has been used to identify gaps in coverage. The fire department is looking to increase staffing in areas where needed, such as Black Mountain Ranch.

With the time change coming up, residents are advised to check their smoke detectors.

Due to rains, grass is high. This will dry out in a couple of months and lead to fire danger. Residents are advised to clear brush around their homes.
