MOTION BY BOARDMEMBER WOODS TO DESIGNATE THE JOSEPH AND ELIZABETH YAMADA/ JOSEPH YAMADA HOUSE LOCATED AT 1676 EL CAMINO DEL TEATRO AS A HISTORICAL RESOURCE UNDER CRITERION B, C, AND D PER STAFF'S RECOMMENDATION. UNDER HRB CRITERION B WITH A PERIOD OF SIGNIFICANCE OF 1973-2020, AND UNDER HRB CRITERION C AND HRB CRITERION D WITH A PERIOD OF SIGNIFICANCE OF 1973. ADDITIONALLY, UNDER CRITERION A AS A RESOURCE THAT REFLECTS A SPECIAL ELEMENT OF LA JOLLA'S HISTORICAL AND SOCIAL DEVELOPMENT WITH A PERIOD OF SIGNIFICANCE OF 1967 TO 1973. THE YAMADAS WERE SOLD THE LAND IN 1967, A FULL YEAR BEFORE THE FAIR HOUSING ACT OF 1968, AND CONSTRUCTED THE HOME IN 1973 WHEN A GENTLEMAN'S AGREEMENT STILL EXCLUDED BLACK, JEWISH, AND ASIAN AMERICAN FAMILIES FROM OWNING PROPERTY IN THE AREA. THE YAMADA HOUSE SET A NECESSARY SOCIETAL PRECEDENT FOR LA JOLLA AND BROADER AREAS OF THE CITY AND IS AN IMPORTANT PIECE OF JAPANESE AMERICAN HISTORY IN SAN DIEGO. THE DESIGNATION INCLUDES THE FRONT YARD LANDSCAPE AND ALL OTHER CONTRIBUTING LANDSCAPE FEATURES IDENTIFIED BY THE CONSULTANT. THE DESIGNATION EXCLUDES NON-CONTRIBUTING LANDSCAPE ELEMENTS SUCH AS THE SIDE YARD GARDEN STRUCTURE, THE REAR YARD PUTTING GREEN, AND THE GENERAL REAR YARD LANDSCAPE. Seconded by Boardmember McCullough. The motion passed by a vote of 7-0-0 with Boardmembers Woods, Winter, McCullough, Farley, Byers, Abrams, and Chair Hutter voting yea, with Boardmembers Cheng, Coyle, and Taylor absent.
