Item 10: Status Report on ECCO Revisions Considered at Rules Committee Meeting of Wednesday, January 21, 2004.

Ms. Fulhorst indicated the ECCO subcommittee would meet to review and discuss the issues and direction given at the Rules Committee meeting, and would bring the proposed ECCO revisions to the full Commission for further discussion and possible action.

Item 11: Proposed Revision to Ethics Commission Operating Policies.

Mr. Mel Shapiro stated there appeared to be a loophole under Conditions of Appointment regarding the Commission member prohibition on making financial contributions to candidates for City office. He suggested that provision be retroactive to the time Commissioners are nominated.

Mr. Mel Shapiro asked about the status of the hiring of the Auditor position for the Ethics Commission.
