- 6. Anticipated training sessions with respect to the District 4 special election.
- 7. Development of an "Interested Persons" email list with respect to campaign financing issues.
- 8. Educational training session for unclassified employees scheduled for Friday, September 24, 2004.
- 9. Continued consultation with San Diego Data Processing Corporation in developing the online recertification training program.
- 10. Planned attendance at COGEL Conference being held in San Francisco in December 2004.
- 11. Consultation with Personnel Department on the procedures necessary to create the General Counsel position with the Ethics Commission.
- 12. At the request of Councilmember Frye, review of ECCO with respect to surplus funds and general election contributions.
- 13. Support to UCSD Panel on creation of a Political Process Management course.
