Item-1: Call to Order

Chairwoman Dorothy Smith called the meeting to order at 5:00 p.m.

Item-6: Commissioner Comment

Commissioner Westfall made the following statement for the record: "As reported, the Commission voted 4 to 2 to dismiss Complaint No. 2004-17. As noted by the Chair, I made one of the dissenting votes. While I respect the process and can accept the Commission's decision, I simply want the record to reflect my strong opinion that it raises serious ethical implications when City Officials use their power or authority over subordinates to secure personal benefits. City Officials should only use their authority to further the public's business. The public trust is not served in any circumstance when personal benefit rather than a public purpose motivate public officials. City employees do not deserve to be placed in untenable positions by City Officials."

In response to Chairwoman Smith, Executive Director Fulhorst stated an important element of education was increased awareness by city employees of the ethics ordinances. She noted a presentation made earlier in the day to the City's Auditor's

office where she emphasized the various aspects of the ethics ordinance. In addition, Director Fulhorst stated she had been in contact with City TV on the concept of developing a five- to ten-minute informational video geared toward classified city employees. The video could be accessed from the Ethics Commission website.

Item-7: Executive Director Comment

Director Fulhorst reported the Civil Service Commission exempted the position of the General Counsel position with the Ethics Commission from the classified service. She further reported she was in contact with the Personnel and Human Resources Departments to advertise the position.

Ms. Fulhorst further reported she was hopeful that the online recertification program being developed with the San Diego Data Processing Corporation would be ready for testing in November.

Item-8: Deputy City Attorney Comment

Item-9: Recent Amendments to the Election Campaign Control Ordinance

Executive Director Stacey explained potential problems with the District Four Special Election should there be a runoff on January 4, 2005, because of various ECCO provisions that are to become effective January 1, 2005.

Motion: Direct staff to pursue the best resolution to exempt District Four candidates from the provisions of ECCO scheduled to become effective January 1, 2005. Moved/Seconded: Leonard/Riel Vote: Unanimous Excused: Thomas-Stefano

Item-10: Appointment of Personnel Ad Hoc Committee with Respect to Recruitment and Employment of Ethics Commission General Counsel

Chairwoman Smith appointed Commissioners Dick and Vega to serve with her on the Ad Hoc Committee for the recruitment and review of candidates for the Commission's General Counsel position.

Chairwoman Smith adjourned the meeting to Closed Session at approximately 5:35 p.m. She stated if the Commission took any action that must be reported pursuant to the Brown Act, the Commission would reconvene into Open Session to report on that action.
