requirements on state committees. She added that the campaign statements are available on the state's online system.

Ms. McGuire concurred with the Director's statement with regard to the state law prohibition on local jurisdictions imposing additional filing requirements.

Director Fulhorst commented on the proposed change to section 27.4050 concerning the ability of the Commission to demand and receive records related to lobbying activities. She noted that the provision includes a reference to the California Business and Professions Code in connection with records that may be subject to the attorney-client privilege. In addition, she pointed out that the City's campaign laws include a similar provision.
