## Item-8: Proposed Amendments to Municipal Lobbying Ordinance

Director Fulhorst reviewed the proposed changes in the draft ordinance that reflect Commission direction provided at the last meeting.

### Item-9: Proposed Amendments to Election Campaign Control Ordinance

Chairman Cabrera commented that a Public Financing workshop has been scheduled at the Rules Committee. He noted that Larry Remer was in attendance in the event that any of the Commissioners wished to receive his input.

Director Fulhorst added that Mr. Remer was attending the meeting in response to concerns expressed at the last meeting regarding the viability of a proposed qualifying threshold that would require candidates to gather \$5.00 contributions from 500 individuals.

Larry Remer indicated that he as well Common Cause endorsed the 500 contribution threshold. He made the following comments in support of the proposal:

- The 500 contribution threshold would eliminate candidates who don't have sufficient community support.
- Review of past election cycles indicates that the candidates could have qualified with a 500 contribution threshold;
- The proposal includes an option to lower the threshold in the event that it becomes evident that the 500 number is too high.

 One of the important anticipated results of the proposal is that it will ensure that candidates make a connection with the community through the qualifying process.

Commissioner Biddle commented that certain parts of the City may be more challenging than others with regard to gathering 500 contributions.

Jeannie Brown of Common Cause commented that one of the goals of Common Cause was to see one California city incorporate clean elections.

Chairman Cabrera commented that although the Commission would not be coordinating its presentation with any outside organizations, he encouraged interested groups to communicate with Council staff and to make presentations during the public comment segment of the Rules Committee.

Director Fulhorst reported that other changes to ECCO consisting of an additional filing requirement, changes to legal defense fund provisions, and clarification regarding telephone communications were approved by the City Council Rules Committee on September 3, 2008. At the request of Council President Peters, the Committee voted to change the term "Legal Defense Funds" to "Professional Expense Funds." She noted that the approved items would be forwarded on to the full City Council for approval.

# Item 10: Proposed Amendments to Investigative and Enforcement Procedures.

Director Fulhorst reported on the Rules Committee's consideration of the Commission's proposed changes. She advised that several recommended changes were referred back to the Commission because the Committee members strongly believe that the full Commission should participate in certain types of decisions such as making probable cause determinations and authorizing hearing subpoenas. She reported that the remaining changes, including the new law regarding providing false information to the Commission, were forwarded on to the full City Council for consideration.

# Item 11: Presentation of Final Audit Report Regarding the Audit of the San Diegans for City Hall Reform Committee.

Commission Auditor Rosalba Gomez presented the Final Audit Report and noted that there were no material findings.
