### **Item-5:** Commissioner Comment

Commissioner Cabrera referred to a media report concerning the Fair Political Practices Commission's investigation of an Assemblyman and suggested that the

Commission staff could monitor local campaign activities to identify similar situations.

Chairman Valdez reported that the Commission has received Commissioner Haney's resignation letter, and that the Mayor and Council have been informed of the vacancy on the Commission.

#### **Item-6: Executive Director Comment**

Director Fulhorst reported on the following matters:

- The Mayor's Office is awaiting a second opinion from the City Attorney's office before moving forward with the appointment process to fill vacancies on the Ethics Commission.
- The Rules Committee voted on September 16, to forward the Commission's proposed changes to the Lobbying Ordinance to the full City Council. However, the City Attorney's Office declined to sign off on the Request for Council Action because of concerns regarding the provision requiring the volunteer chair of an organization lobbyist to report his or her lobbying activities. In order for the changes to be effective January 1, 2010, they will need to be scheduled for Council approval by November 10, 2009. The City Attorney will need to sign off on the request for Council Action by October 27, in order to meet this deadline.

Chairman Valdez asked if the City Attorney's Office has any other concerns with the proposed changes.

Director Fulhorst responded that staff is not aware of any others, although they could have developed more concerns since their last communication with staff.

Chairman Valdez advised that at the September 16 Rules Committee meeting, the Committee approved the Commission's recommended amendments and directed the Commission to review the current exemption for public agency consultants.

He stated that in response to the Committee's request, the Commission docketed this matter in order to receive public input. He advised that the item will also be docketed for discussion at the November meeting.

Simon Mayeski commented that in the interest of disclosure, he supports eliminating the exemption for consultants representing public agencies.
