Item-1: Call to Order

Chairman Valdez called the meeting to order at 5:00 p.m.

Item-4: Non-Agenda Public Comment

Chairman Valdez noted that Jacob Pyle and Drew McGuire submitted speaker slips requesting to speak on a matter concerning the *San Diego Safe Beaches Coalition*, and that Mr. McGuire asked if he could donate his time to Mr. Pyle. He stated that the Commission generally does not allow speakers to donate their time to another speaker, but that he would permit it in this instance because Mr. McGuire was planning to simply read the second half of prepared remarks after Mr. Pyle completed reading the first half.

Jacob Pyle commented that he is the former volunteer assistant treasurer for the San Diego Safe Beaches Coalition and is currently named as a respondent in an

Ethics Commission investigation of the committee. He requested that the Commission schedule the probable cause hearing in this matter as far as possible after February 23, to allow him time to prepare after taking the California Bar Exam. In addition, he requested that the Commission modify stipulations in two other enforcement matters by removing references to him personally and to the *San Diego Safe Beaches Coalition*.

Chairman Valdez clarified that the Commission would not be addressing his comments because the Commission's policy doesn't allow discussion of pending investigations.

Robert Rynearson representing the organization FreePB.org, asked the Commission to modify stipulations in two other enforcement matters by removing references to him personally and to FreePB.org.

Commissioner Cabrera announced that he is resigning from the Commission effective at the end of the March 11, 2010, Commission meeting. He noted that due to the City Council's inability to appoint or re-appoint commissioners, four of the current Commissioners are serving on expired terms. He hopes that his resignation will clear the way for appointments. He noted that his resignation letter to the Mayor includes recommended changes to the appointment process for the Ethics Commission.
