### Item-1: Call to Order

Commission Chair Westfall called the meeting to order at 5:00 p.m.

#### Item-4: Non-Agenda Public Comment

Simon Mayeski invited the Commissioners and staff to the 40<sup>th</sup> anniversary celebration of Common Cause on November 13, 2010 at 5:00 p.m. at the Joan Kroc Peace and Justice Center. He added that former Ethics Commissioners Gil Cabrera and Dorothy Leonard will be honored at the event.

Commission Chair Westfall welcomed new Commissioners Faye Detsky-Weil and William Howatt.

#### Item-6: Executive Director Comment

Director Fulhorst provided an update on the Request for Qualifications process for General Counsel services. She explained that she anticipates interviewing qualified firms in mid-November and noted that Commissioners O'Neill and Howatt have agreed to assist her and Commission Chair Westfall with this process.

Commissioner Fuller asked how hiring an outside law firm to provide General Counsel services compares with hiring a full-time staff attorney.

Director Fulhorst explained that, although the hourly rate for an outside law firm will be higher than an hourly rate for a staff attorney, the Commission would not incur the costs of fringe benefits associated with the staff position. Moreover, she explained that she anticipates retaining an outside firm to provide only part-time General Counsel services, which would result in budgetary savings that could be used to pay for Administrative Law Judges to preside over Commission hearings, and outside counsel to serve as Petitioners.

#### Item-8: Proposed Amendments to Commission's Investigative and Enforcement Procedures

Director Fulhorst reported that the proposed amendments to the Municipal Code would provide the Ethics Commission with the option of paying an administrative law judge from the State Office of Administrative Hearings [OAH] to preside over Ethics Commission administrative hearings. She pointed out that other agencies in California routinely use the OAH for their hearings, and that it would eliminate the need for volunteer Commissioners to devote their time to serve as hearing officers.

She explained that under the proposed procedures, the OAH would preside over the hearing and prepare a written recommendation. The Commission would then consider the recommendation at a Commission meeting, and would make a final decision regarding the alleged violations and the fine. She noted that the OAH charges approximately \$185 per hour.

Commissioner Fuller asked if staff could provide a rough estimate of the costs that would have been incurred if the OAH had presided over the Commission's previous administrative hearings.

Director Fulhorst responded that it would be difficult to estimate the number of hours that an Administrative Law Judge would have spent on a particular matter. She

pointed out that the proposed amendment would add the OAH as an option, and that the Commissioners could still opt to preside over a hearing themselves if there are budgetary concerns.

Commission Chair Westfall pointed out that it would be difficult to use a cost comparison based upon the number of hours the Commissioners spent on previous hearings because administrative law judges may have handled the hearings more efficiently.
