Item-8: Application of Pre-Election Fundraising Time Constraints to 2012 Primary Election

Director Fulhorst reported that there have not been any substantive developments with respect to the state changing the date of the 2012 primary election. She explained that a Senate bill has been introduced that would essentially eliminate one comma in the existing law, and that it is her understanding that the bill was introduced to initiate a discussion concerning the primary election date. Neither the Assembly bill nor the Senate bill has been docketed for committee consideration. She will report back to the Commission in April regarding any developments.

Item-9: Staff Report Concerning Lobbying Activity in 2009 and 2010

Director Fulhorst reported on a summary of lobbying activities disclosed by lobbying firms and organization lobbyists in 2009 and 2010. She noted that the report demonstrates that the new lobbying laws that were enacted in 2008 are working well, with many more lobbyists registering. She pointed out that, under the former laws, many lobbyists were not captured by the registration thresholds and did not have to register. In addition, she pointed out that more information is being disclosed by lobbyists concerning lobbying and campaign activities, resulting in increased transparency. Finally, she noted that the increased levels of disclosure have not resulted in voluminous disclosure reports.

Commissioner Westfall noticed that the fundraising activity disclosed by lobbyists was higher in 2010 than 2009. He commented that the total amount reportedly fundraised by lobbyists in 2010 did not seem very high, and he asked if the staff currently audits the lobbying disclosure reports.

Director Fulhorst responded that currently the Audit Manual provides only for the lobbying of lobbyist activity expenses, which has become moot in light of the new \$10 monthly gift limit. She explained that auditing of fundraising activity would not be feasible because campaigns are not required to track or report fundraising activity. Therefore, an investigation would be required in order to verify fundraising information disclosed by lobbyists.

Commissioner Biddle indicated that, in his experience, people are not inclined to downplay their fundraising efforts for candidates. He added that such activities can be difficult to track from a candidate's perspective.

Commissioner Howatt commented that the summary of activity was well done and asked whether there had been any questions from the media regarding the report. Director Fulhorst responded that she had not yet received any such inquiries.

Commissioner O'Neill asked whether staff had received any feedback or complaints from lobbyists regarding difficulties complying with the disclosure requirements. Director Fulhorst explained that staff did receive complaints during 2008 after the new laws went into effect, but the Commission addressed these complaints with a series of amendments that went into effect on January 1, 2010. Since that time, she reported that the staff has received nothing but positive feedback from lobbyists.
