

Minutes for Meeting of Thursday, June 9, 2011

Item-1: Call to Order

Commission Chair Westfall called the meeting to order at 5:00 p.m.

Item-6: Executive Director Comment

Director Fulhorst reported that the City Council has not yet docketed the confirmation of the Mayor's reappointment of Commissioners Detsky-Weil and O'Neill. With respect to the replacement of Commissioner Westfall, she noted that she spoke with the Mayor's Board and Commission Liaison and was informed that while they have called for nominations, none have been received to date.

Item-7: General Counsel Comment

Ms. Cameron reported on a decision made by the Ninth Circuit Court of Appeals concerning the City's campaign laws. Ms. Cameron briefly recapped the lawsuit brought by Phil Thalheimer and other plaintiffs to enjoin the City from enforcing the following laws:

- limiting contributions to general purpose committees to \$500 when used to support or oppose City candidates;
- the temporal contribution ban that prohibits raising money more than 12 months before the primary election;
- the ban on organizational contributions to City candidates; and
- the \$500 contribution limit to City candidates.

Ms. Cameron explained that the plaintiffs initially filed a request for a preliminary injunction, which was granted in part and denied in part. This decision was then appealed to the Ninth Circuit, which essentially upheld the decisions of the lower court. Because the Ninth Circuit decision was made by a three-judge panel, the plaintiffs could ask the entire Ninth Circuit to re-hear the case. It is also possible the matter may come back to the lower court for a trial on the merits.

Commission Chair Westfall noted that it has been a while since the Commission last discussed this litigation. Director Fulhorst commented that the City has been awaiting a decision from the Ninth Circuit for approximately eight months. Director Fulhorst also noted that the Ninth Circuit decision coincidently had come out on this day, June 9, 2011.

Item-8: Election of Chair and Vice Chair

Commission Chair Westfall reminded the Commission that the ad hoc nominating committee was comprised of Commissioners Detsky-Weil and Wetzler.

Commissioner Detsky-Weil advised the Commission that the ad hoc committee would like to nominate Commissioner Fuller as the Commission Chair and Commissioner Howatt as Vice-Chair. It was also noted that both Commissioners were asked if they would serve and both agreed to do so.
