Commission Chair O'Neill reported that he was recently approached by a lobbyist who informed him that the lobbying community does not have a clear understanding of the rules applicable to expenditure lobbyists. He therefore suggested that the staff emphasize this issue during the course of its educational efforts. Ms. Fulhorst responded that she recently scheduled three lobbyist refresher training sessions and that issues associated with expenditure lobbying will be addressed during these sessions.

#### Item 6: Executive Director Comment

Ms. Fulhorst informed the Commission that the proposed amendments to the City's campaign laws are tentatively scheduled to be considered by a Council Committee on September 22, 2014. She added that Paul Ryan with the Campaign Legal Center will be preparing a memo in support of the proposed amendments that will be submitted with the package of materials for Council Committee consideration.

Ms. Fulhorst also reported that the City Clerk's Office will be implementing significant improvements to the lobbyist electronic filing system during the current fiscal year. Currently, the public must review each lobbyist filing individually in order to obtain information about lobbying activities. The improvements will include search capabilities that will enable the public to search for specific data contained in all lobbyist filings.

Finally, Ms. Fulhorst reported that the staff has updated the Commission's website to include a brief description of the nature of the violation for each stipulation.
