#### Item 6: Executive Director Comment

Ms. Fulhorst summarized the staff advisory memo recently issued to the Mayor and City Council concerning the application of conflict of interest laws to the City's procurement of wireless services. She explained that the City's conflict laws pertaining to contracts, which are modeled on California Government Code section 1090, prohibit a legislative body from entering into a contract if one of the members of the body has a financial interest in the contract. The prohibition applies even if the conflicted member recuses from participating in the decision. As reflected in the memo, staff concluded that the City Council could not approve the procurement agreement because Councilmember Lightner's spouse works for a company that is a subsidiary of a wireless provider. Ms. Fulhorst explained that the prohibition does not apply to the Mayor or anyone working in the executive/operational branch of City government. Accordingly, City staff is currently working to identify alternative avenues to contract for wireless services that will not involve City Council approval.

Ms. Fulhorst reported that Program Manager Steve Ross has converted twelve years of case logs in Word format to a single database with enhanced functionality that enables staff to conduct searches, run reports, and generate statistics. She thanked Mr. Ross and Administrative Aide Jennifer Duarte, who input all the necessary information into the new database.
