WHAT YOU **NEED** TO KNOW.

Auto Insurance Relief For (At Least) March and April

My office is working to provide Mid-City and South San Diego County residents with the latest information on the impact the novel coronavirus, known as COVID-19, is having on our community.

California's "stay at home" order has resulted in most of us driving a lot less than we normally would. Recognizing this and the unprecedented challenges facing California's residents, [State Insurance Commissioner Ricardo Lara has ordered](#) insurance companies to provide consumers with relief from the cost of premiums during the COVID-19 pandemic. You can expect a temporary reduction in your auto insurance for at least the months of March and April, and maybe for May if the shelter-in-place order is extended.

Commissioner Lara ordered auto insurance companies to provide premium credits, reductions or adjustments for customers to reflect the fact that people are not driving now and the risk of accidents is much lower. Many insurance

carriers voluntarily provided reductions over the last two weeks, but this directive ensures voluntary actions will not discriminate against any groups of drivers.

Here's a list of what some larger companies have proposed to give back to customers on personal auto insurance policies, subject to review and approval from the Insurance Commissioner:

- AAA: Customers with an active policy as of April 30 will receive a 20 percent refund for two months of auto premiums
- Allstate: 15 percent debit or credit payback on April and May premiums
- American Family: \$50 per vehicle insured
- Amica: 20 percent credit on April and May premiums
- Farmers/21st Century: 25 percent reduction in April premium
- Geico: 15 percent credit on renewal between April 8 and Oct. 7; pausing cancellations for non-payment through April
- The Hartford: 15 percent credit on April and May premiums
- Liberty Mutual: 15 percent refund on two months of premiums
- Mercury Insurance: 15 percent credit on April and May premiums
- Nationwide: \$50 refund per policy
- Next: 25 percent reduction to its policyholders' April general liability, and commercial auto premiums
- Progressive: 20 percent credit on April and May premiums
- Safeco: 15 percent refund on two months of premiums
- State Farm: 25 percent credit on premiums from March 20 through May 31
- Travelers: 15 percent credit
- USAA: 20 percent credit on two months of premiums

The Insurance Commissioner has also requested that all auto insurance carriers provide [a 60-day grace period for late payments](#). If you are unable to pay your insurance premium, contact your provider and ask them to honor the Insurance Commissioner's request to provide a 60-day grace period.

Alivio del Seguro de Automóvil Para (Al Menos) Marzo y Abril

Mi oficina está trabajando para proveer a los residentes de Mid-City y el Sur del condado de San Diego la información más reciente sobre el impacto que el nuevo coronavirus, conocido como COVID-19, está teniendo en nuestra comunidad.

La orden de "quedarse en casa" de California ha dado lugar a que la mayoría de nosotros conduzcamos mucho menos de los que normalmente haríamos. Reconociendo esto y los desafíos sin precedentes a los que se enfrentan los residentes de California, [el Comisionado estatal de Seguros Ricardo Lara ha ordenado](#) a las compañías de seguros que brinden a los consumidores alivio del costo de las primas durante la pandemia COVID-19. Puede esperar una reducción temporal en su seguro de automóvil durante al menos dos meses de marzo y abril, y tal vez para mayo si la orden de quedarse en casa se extiende.

El Comisario Lara ordenó a las compañías de seguros de automóviles que proporcionan créditos, reducciones o ajustes de prima para los clientes y que reflejan el hecho de que la gente no está conduciendo ahora y el riesgo de accidentes es mucho menor. Muchos seguros conllevan reducciones voluntarias en las últimas dos semanas, pero esta directive garantiza que las acciones voluntarias no discrimine a ningún grupo de conductores.

Aquí está una lista de los que algunas compañías han propuesto para devolver a los clientes en las pólizas de seguro de automóviles personales, sujeto a la revisión y aprobación del Comisionado de Seguros:

- AAA: Los clientes con una póliza activa a partir del 30 de abril recibirán un reembolso del 20 por ciento por dos meses de primas de automóviles.
- Allstate: 15 por ciento de débito o devolución de crédito en primas de abril y mayo
- American Family: \$50 por vehículo asegurado
- Amica: 20 por ciento de credito en primas de abril y mayo
- Farmers/21st Century: Reducción de 25 por ciento en la prima de abril
- Geico: 15 por ciento de credito en renovación entre el 8 de abril y el 7 de octubre; pausando las cancelaciones por falta de pago a través de abril
- The Hartford: 15 por ciento de credito en primas de abril y mayo
- Liberty Mutual: 15 por ciento de reembolso en dos meses de primas
- Mercury Insurance: 15 por ciento de credito en primas de abril y mayo
- Nationwide: Reembolso de \$50 por póliza
- Next: Reducción del 25 por ciento en las primas de automóviles comerciales y la responsabilidad general de sus asegurados en abril
- Progressive: 20 por ciento de credito en primas de abril y mayo
- Safeco: 15 por ciento de reembolso en dos meses de primas
- State Farm: 25 por ciento de credito en primas del 20 de marzo hasta el 31 de mayo
- Travelers: 15 por ciento de credito
- USAA: crédito del 20 por ciento en dos meses de primas

El Comisionado de Seguros también ha solicitado que todas las compañías de seguros de automóviles proporcionen [un periodo de gracia de 60 días para pagos atrasados](#). Si no puede pagar su seguro, comuníquese con su proveedor y pídale que respete la solicitud del Comisionado de Seguros de proporcionar un periodo de gracia de 60 días.
