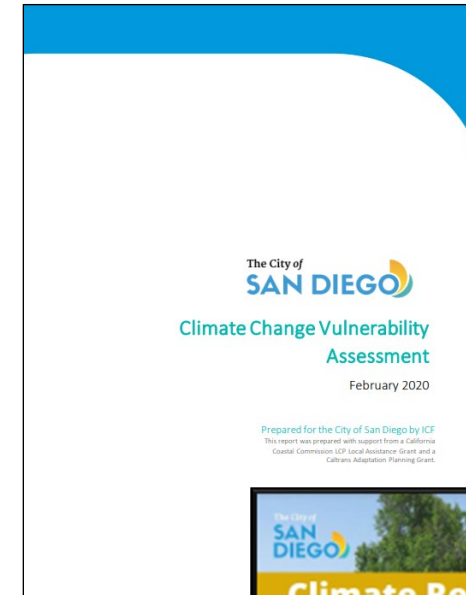

- Implement City's climate resilience goals



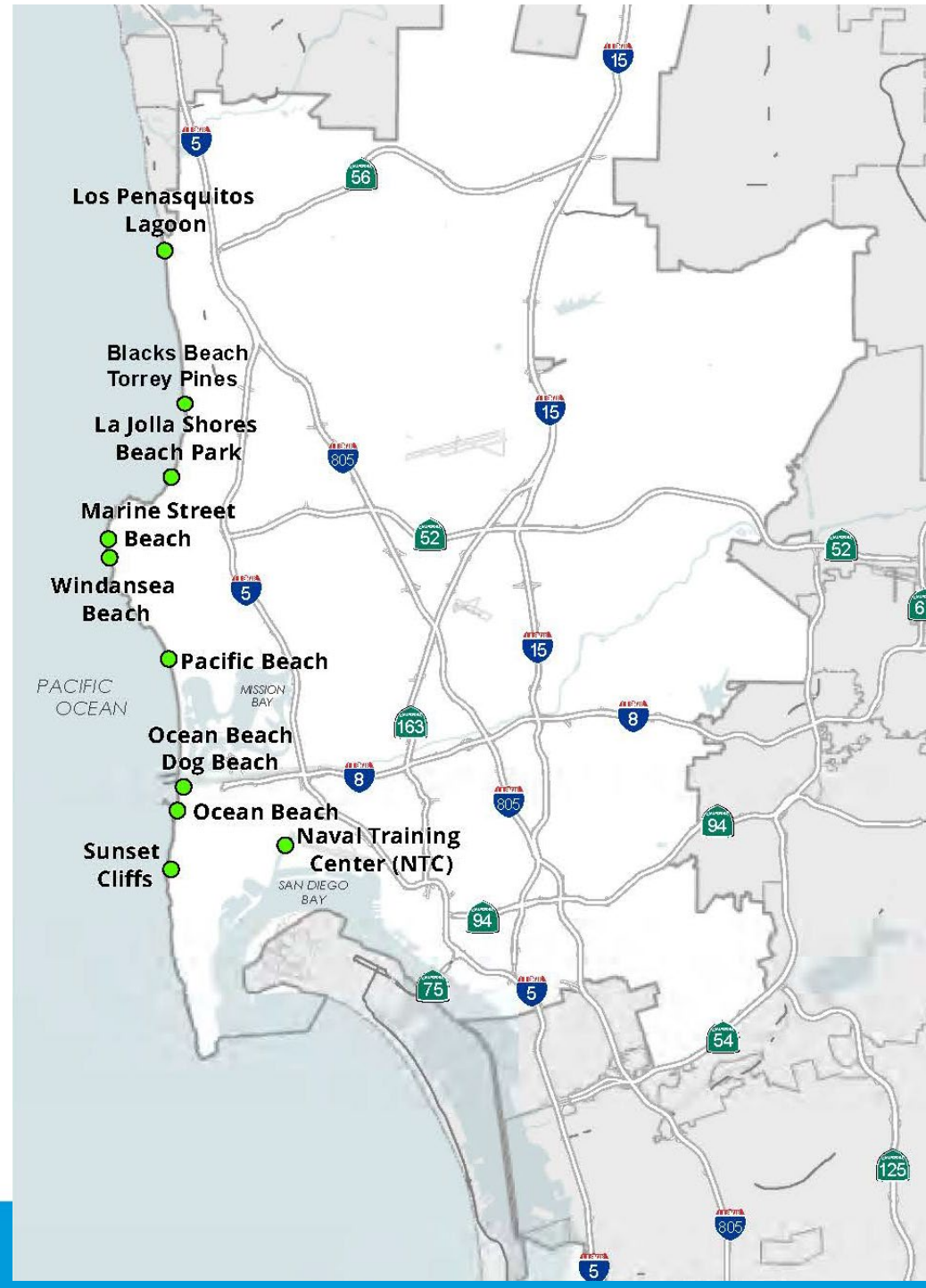


Project Scope

- Programmatic Environmental Impact Report



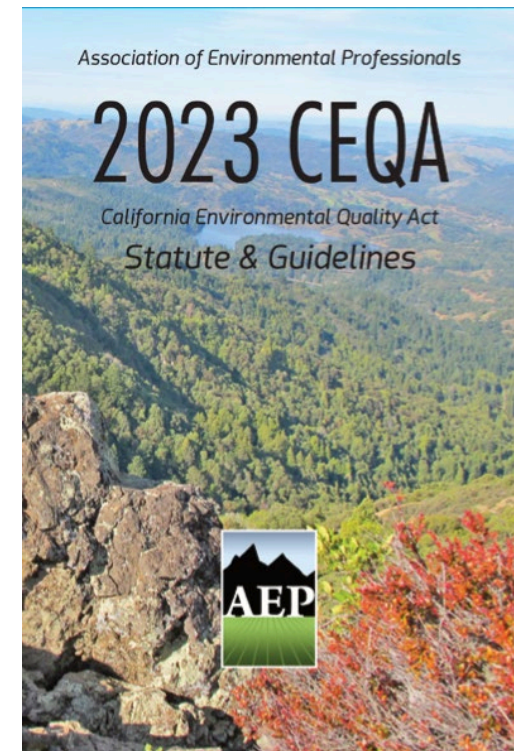
Project Location



Environmental Review Process

California Environmental Quality Act (CEQA)

- Inform public and decision makers of potential significant environmental effects
- Encourage public involvement
- Notice of Preparation marks the beginning of the environmental review process





Environmental Impact Report (EIR) Purpose

- Disclose the project's potential significant effects on the physical environment
- Identify mitigation measures to avoid or reduce environmental impacts
- Analyze a reasonable range of alternatives
- Foster public review/participation



Notice of Preparation

- Contains a brief description of the project, including potential project location(s), and where documents relating to the project can be found
- Notifies responsible agencies and other interested parties that an EIR will be prepared
- Distributed for a 30-day public review period
(May 5 – June 5, 2023)

Purpose of Scoping Meeting

Receive public input on the scope of environmental issues in the Draft EIR:

- Energy
- Geologic Conditions
- Greenhouse Gas Emissions
- Hazards and Hazardous Materials
- Historical, Archaeological, and Tribal Cultural Resources

- Public Utilities
- Transportation and Circulation
- Visual Effects and Neighborhood Character
