## *Introduction*

---

This report provides an analysis of the financial and administrative obligations of Community Facilities District No. 1 (Miramar Ranch North) (“CFD No. 1”) of the City of San Diego (the “City”) resulting from the sale of the \$35,340,000 Series 1991 Special Tax Bonds (“Series 1991 Bonds”) and the \$20,865,000 Series 1995 Special Tax Bonds (“Series 1995 Bonds”) which were refunded by the sale of the \$59,465,000 Series 1998 Special Tax Refunding Bonds (the “Series 1998 Bonds”) issued in July 1998. The Series 1998 Bonds were subsequently refunded by the sale of the \$24,795,000 Series 2012 Special Tax Refunding Bonds (the “Series 2012 Bonds”) issued in June 2012.

CFD No. 1 is a legally constituted governmental entity established under the Mello-Roos Community Facilities Act of 1982, (the "Act") as amended. The Act provides an alternative method for the financing of certain public capital facilities and services. Specifically, CFD No. 1 was originally authorized to issue up to \$73,000,000 in bonds and has sold a total of \$56,205,000 in Series 1991 Bonds and Series 1995 Bonds. At the time of issuance of the Series 2012 Bonds, the City covenanted not to issue additional bonds. The proceeds of the Series 1991 Bonds and Series 1995 Bonds were used to finance the acquisition and construction of certain parks/open space, road, water, sewer, fire and library related facilities necessary to meet increased demands placed on the City of San Diego as a result of the development of CFD No. 1.

On November 30, 1993, the City Council approved modifications to the original Rate and Method of Apportionment with the adoption of Resolution R-283093. The resolution ordered changes to the tax formula to allow partial prepayments of the special tax and modified the maximum special tax to be applied to developed and undeveloped property. Any discussion made herein regarding the Rate and Method of Apportionment (“RMA”) reflects the modified version of the RMA as approved on November 30, 1993.

The bonded indebtedness of CFD No. 1 is both secured and repaid through the annual levy and collection of special taxes from all property subject to the tax within CFD No. 1. In calculating the special tax liability for fiscal year 2013-2014, this report examines the financial obligations of the current fiscal year and analyzes the level of development within CFD No. 1.

A map showing the property in CFD No. 1 is included in Exhibit A.

The information provided in this report is derived primarily from documents developed at the time CFD No. 1 was formed and from data provided by the City or accessed through the City building permit system. The information sources include the RMA, annual budget information for CFD No. 1, the debt service schedule, and building permit information accessed through the City’s building permit system, special tax delinquency data provided by the County of San Diego, builder provided information, and historical development status and special tax prepayment records maintained by David Taussig & Associates.

Section IV reviews the methodology used to apportion the special tax requirement between Developed Property and Undeveloped Property. A table of the 2013-2014 special taxes for each classification of property is included.

# ***I. Special Tax Classifications and Development Update***

---

## **Special Tax Classifications**

The methodology employed to calculate and apportion the special tax is contained in a document entitled the Rate and Method of Apportionment. The Rate and Method of Apportionment defines two primary categories of taxable property, namely "Developed Property" and "Undeveloped Property." The category of Developed Property is in turn divided into four separate rate classifications which vary with land use (e.g., residential, commercial, industrial and other). A table of the Developed Property classifications is shown below.

<b>Class</b>	<b>Designation</b>
1	Residential Property
2	Commercial Property
3	Industrial Property
4	Other Property

Developed Property is generally distinguished from Undeveloped Property by the issuance of a building permit. Specifically, property for which a building permit was issued prior to March 1 will be classified as Developed Property in the following fiscal year.

## **Development Update**

CFD No. 1 consists of approximately 1,200 gross acres located approximately 15 miles north of the City's downtown area and ten miles inland.

CFD No. 1 is 100% built-out with 3,125 residential units and 27.11 acres of commercial development. The table on the following page indicates the cumulative Developed Property, by class, within CFD No. 1.

## ***II. Fiscal Year 2012-2013 Special Tax Levy***

---

The aggregate special tax levy for fiscal year 2012-2013 equaled \$3,772,322. As of June 20, 2013, \$3,752,166 in special taxes had been collected by the County. The remaining \$20,156 in special taxes are delinquent, resulting in a delinquency rate of 0.53 percent.

Pursuant to the Bond Indenture, CFD No. 1 has covenanted to determine each year whether or not any owners of property within CFD No. 1 are delinquent in the payment of their special taxes. If such delinquencies exist, CFD No. 1 is required to commence judicial foreclosure proceedings no later than October 1 against all delinquent parcels, provided however, that CFD No. 1 is not required to commence foreclosure proceedings if (a) the total special tax delinquency in CFD No. 1 for such fiscal year is less than 5% of the total special tax levied in such fiscal year and (b) the amount then on deposit in the Reserve Fund is equal to the Reserve Requirement. Notwithstanding the foregoing, if CFD No. 1 determines that any single property owner in CFD No. 1 is delinquent in excess of \$10,000 in the payment of the special tax, then it will diligently institute, prosecute and pursue foreclosure proceedings against such property owner.

At this time, CFD No. 1 is not required to commence foreclosure proceedings.

### ***III. Fiscal Year 2013-2014 Special Tax Requirement***

---

For fiscal year 2013-2014, the special tax requirement is equal to \$3,717,716 and is calculated below.

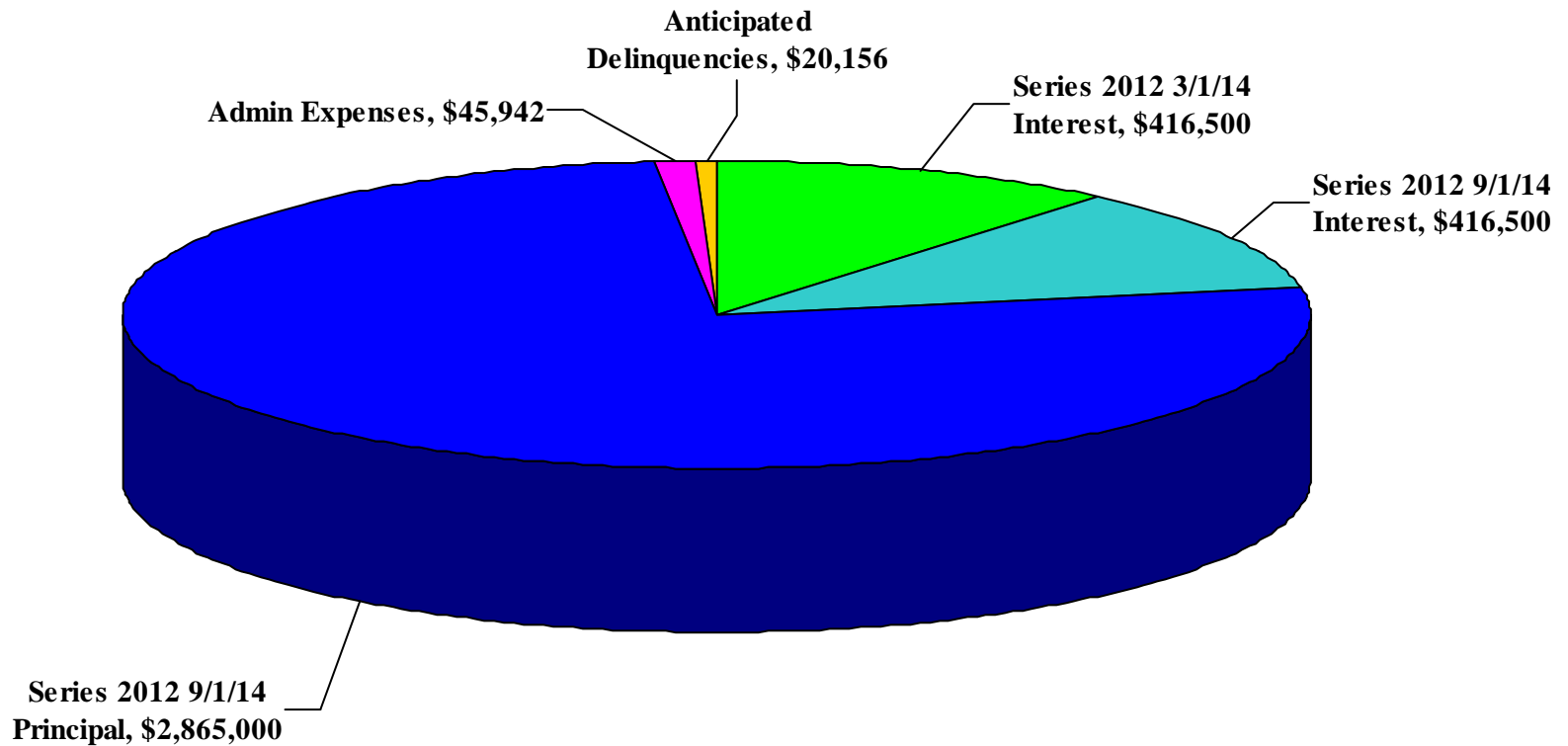

## ***IV. Method of Apportionment***

---

### **Maximum Special Taxes**

The amount of special taxes that CFD No. 1 may levy is strictly limited by the maximum special taxes set forth in the Rate and Method of Apportionment. Pursuant to Section E of the Rate and Method of Apportionment, the special tax shall be levied on each assessor's parcel of Developed Property for a maximum of 25 years. The first year in which special taxes were levied on Developed Property in CFD No. 1 was fiscal year 1994-1995. Therefore, special taxes will have been levied for 25 years on the 75 assessor's parcels of Developed Property for which building permits were issued as of March 1, 1994 in fiscal year 2018-2019. No special taxes will be levied on such assessor's parcels starting in fiscal year 2019-2020. The final maturity on the outstanding Series 2012 Bonds is September 1, 2020 and it is not anticipated that special taxes will be levied after fiscal year 2019-2020.

The fiscal year 2013-2014 maximum special tax rates for each classification of property are shown in the table in the following section.<sup>1</sup>

### **Apportionment of Special Taxes**

The special tax that is apportioned to each parcel is determined through the application of Section D of the Rate and Method of Apportionment. Section D apportions the special tax requirement in three steps which prioritize the order in which Developed Property and Undeveloped Property are taxed.

The first step states that the special tax shall be levied against each parcel of Developed Property at up to 100 percent of the maximum special tax. If the special taxes raised pursuant to the first step are less than the special tax requirement, then the second step is applied. The second step states that the special tax shall be levied against each parcel of Undeveloped Property at up to 100 percent of the maximum special tax. The third step is designed to accommodate changes in land use and is intended to be used only as a last resort. Since sufficient revenue is generated from the application of the first step, the last two steps are not necessary.

As discussed in Section III, the fiscal year 2013-2014 special tax levy is equal to the special tax requirement, which results in a special tax on each parcel of Developed Property that is equal to approximately 59.48 percent of the maximum special tax. The fiscal year 2013-2014 maximum and actual special taxes are shown for each classification of Developed Property and Undeveloped Property in the following table and graphically on the following page.

<sup>1</sup> Pursuant to the RMA, the maximum special tax can be increased each year by the percentage increase in the actual construction costs. The maximum special taxes will not be increased from the amounts shown in the RMA because all construction has been completed.

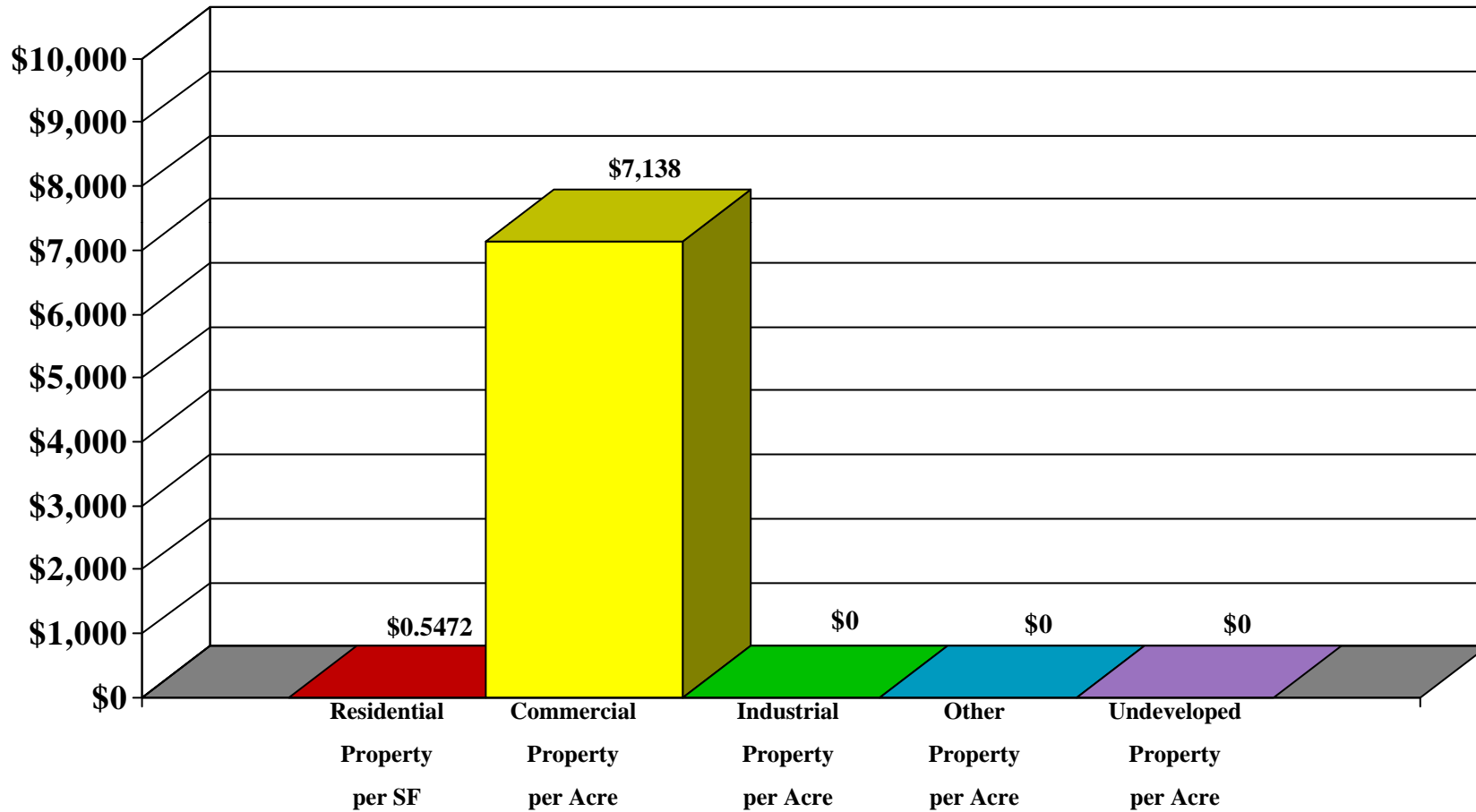
