#### **ITEM DESCRIPTION:**

This Action would authorize the Mayor, or designee, to enter into a Licensing Agreement with Mattel Inc., allowing for its use of the City's Fire-Rescue Department and Divisions names and logos in conjunction with the manufacture, marketing, and sale of various scaled Matchbox® toy replicas of fire apparatus and lifeguard vehicles, for a 3-year term with the option to renew for one additional 2-year term.

Declaring that the restriction contained in San Diego Municipal Code Section 86.0126, that prohibits a person from allowing a vehicle to remain parked in any parking meter zone when the meter, receipt, card, or electronic device shows the parking time has expired shall not apply to any vehicle, or operator of the vehicle, available for rent pursuant to the terms of the Pilot Program and an Agreement with the City as described in Section 3 of this ordinance.

\* ITEM-57: Amendment No. 3 to Cooperative Agreement with Caltrans for the Construction of Carroll Canyon Road Extension Project. (Torrey Pines and Mira Mesa Community Areas. Districts 1 and 6.)

#### **ITEM DESCRIPTION:**

This action will authorize the execution of Amendment No. 3 to Cooperative Agreement with Caltrans. The proposed Agreement would compensate Caltrans in the amount not to exceed \$900,000 for the reconstruction of the City's existing storm drain system in Carroll Canyon Road, east of Scranton Road. In addition, this action will appropriate and expend by an amount not to exceed \$40,000 in interest earnings for the purpose of City Staff Oversight.
