There are many areas of the City's template that require additional documentation and information unique to City Council District 4. The Bylaws Committee is requesting consideration of sending a letter requesting extension related to completion of the bylaws requirement until City Council District 4 has City Council representation as discussed and per Attachment A. It was M/S/C and amended (Leslie, Michael, and Andrea; 8 ayes, 0 nays, 0 abstentions) that the CVCPG send a letter (Attachment A) to the Mayor, all City Council Representatives, the City Planning Department Director, and the Community Planning Group Coordinator requesting an extension of the deadline for completing bylaws until Council District 4 has representation. Sally spoke to Marlon Pangilinan, Community Planning Group Coordinator, regarding 12/31/23 deadline and the additional concern that CVCPG does not have Council representation or a place to meet as the library is undergoing renovation and preparing for upcoming elections. He indicated that all bylaws must be completed and approved by 1/31/24. Sally also mentioned that at the 11/27/23 City Planners Committee meeting, only three groups had bylaws completed. All parties that can participate in the 12/12/23 City Council Meeting were encouraged to do so to express public comment concern about delaying the CVCPG bylaws requirement until District 4 has Council representation as well as to address concerns about City Council voting on measures that impact our district while we do not have representation. In the meantime, the Bylaws Committee will continue to meet to work on the bylaws so they can be completed and approved by 1/31/24 deadline.
