1. **Call to Order/Introduction of Members:** Otay Mesa Nestor Community Planning Group (OMNCPG) Vice-Chair, Jacki Farrington, called the meeting to order at 6:35 p.m. She welcomed all Board members and members of the community to the meeting.
2. **Approval of the Minutes:** A motion was made by Patty Swanson to approve the minutes of the February 13, 2019, OMNCPG meeting. Motion approval was unanimous.
3. **Non-Agenda Public Comments:** (2-minute limit per speaker).
  - a. Bobby Hicks mentioned the crosswalk markings for Berry Elementary at Saturn Blvd. and Rimbey Avenue were removed and have not yet been replaced.
  - b. Sabine Prather attended the City of San Diego Community Planners Committee Meeting downtown. She mentioned that proposed Parking Reduction Requirements in Transit Priority Areas by the City Council was the main concern. She also mentioned that parking is free if you contact them ahead of time.

  - a. Officer Liufau introduced the new San Diego police Department Southern Division Captain Manuel Del Torro, and she also introduced Lt. Juan Sanchez.
    1. Captain Del Torro then spoke and thanked the OMNCPG for our concern for our community.

6. **Council District 8 Report:** Gerardo Ramirez, Council Representative, 619-236-6688 [gramirezborj@sandiego.gov](mailto:gramirezborj@sandiego.gov)
  - a. Gerardo provided handouts from Councilmember Vivian Moreno's office.
  - b. He stated that on March 14, 2019, the City Council approved the city-wide Transit Priority Areas Multifamily Residential Parking Standards for Multi-Family Housing Units in Transit Priority Areas.
  - c. He said that the City of San Diego Otay Valley Regional Park – Citizens Advisory Committee (CAC) stills needs an additional member.

- d. He also mentioned that the Fiscal Year 2020 Recreation Center Budgets were just proposed. It was noted that the Carmel Mountain Valley budget was 13 times larger than the South Bay budget. Councilmember Moreno requested an amendment explaining how equity in this budget would be demonstrated in all parts of the City.

8. **Sub-Committee Reports:**
- A. Volunteer Code Compliance, By-Laws, and Parks and Recreation subcommittees. No report.
- B. Election Sub-Committee: As required by the by-laws, the Election Sub-Committee prepared a ballot and conducted an election of OMNCPG members at this meeting.
