- 1. **Call to Order/Introduction of Members:** Albert Velasquez, the chair of the Otay Mesa Nestor Community Planning Group (OMNCPG) Albert Velasquez, called the meeting to order at 6:34 p.m. He welcomed all Board members and members of the community to the meeting.
- 2. **Approval of the Minutes:** The minutes of both the April 10, 2019, and May 8, 2019, OMNCPG meetings will be reviewed for approval at the upcoming June 12, 2019 OMNCPG meeting.
- 3. Non-Agenda Public Comments: (2-minute limit per speaker).
 - a. Robert Broomfield mentioned a parking issue with Nestor Plaza which had been resolved, and he wanted to thank those involved in that resolution.
 - b. Bob Mikloski asked about having to buy new trash cans if the city trash truck damages them. Black trash cans have a ten year warranty but after that, the homeowner bears the cost. If they need replacement before the ten years expires then the cost is pro-rated.
 - c. Bobby Hicks stated that RV owners have parked on his street and then ran an extension cord to his electrical outlets to obtain free electricity.
- 4. **San Diego Police Department Report:** SDPD Officer Aida Liufau, <u>aliufau@pd.sandiego.gov</u> (619) 424-0412.
 - a. Officer Aida Luifau announced that she is being promoted to investigator, and Officer Carlos Eddington will be taking over her position.
 - b. Officer Aida Liufau stated that the RVs can be cited for illegal parking if they are in violation of the City of San Diego Ordinance.
 - 1. Officer Luifau also said that in general, no RV's are allowed on city streets between 2 a.m. and 6 a.m. During the day, if an RV is more than 27 feet long and parked too close to an intersection, it can also be cited. Any vehicle parked more on the city streets more than 72 hours can also be cited.
 - 2. She urged citizens to use the City of San Diego Get It Done app if they have any concerns about neighborhood issues.

 - d. Gerardo also stated that GSA will be conducting another closure of southbound I-5 freeway traffic at the SR-905 connector on May 13, 2019 at 10:00 p.m. until May 14, 2019 at 7:00 a.m.
 - e. Gerardo responded to a request for additional neighborhood clean-ups, mentioning that several events with 100 volunteers had occurred, and other clean-ups could be planned.
 - f. John Swanson asked about the equity issue about our local park funding. Gerardo stated that the City of San Diego final budget, which includes this item, will be considered for approval by the City Council on July 15, 2019.
