 - Continuing Coffee with Campillo => Councilmember Campillo will be in Tierrasanta at Industrial Grind on Saturday April 20, 2024 from 8-9:30 a.m. to chat with Tierrasanta residents. Coffee will be provided
 - Complete new asphalt overlay will be applied to Tierrasanta Blvd from the I-15 S on-ramp to far east end past Colina Dorado Drive. Work will begin after Memorial Day is anticipated to require 2-3 weeks to complete (estimate based on previous projects of similar size)
 - Clairemont Mesa Blvd resurfacing will be the next large road project to be addressed in Tierrasanta in partnership with CalTrans
 - Bob Lang asked Vic Vettiyil if Councilperson Campillo supports the proposed sales tax increase in San Diego. Vic responded that Councilperson Campillo spearheaded the effort and is therefore in favor

 - Canyon Hills High School just had their winter formal dance
 - Work on the new softball field has started
 - New bleachers are being installed in the football stadium. The hope is have the work completed before the next season begins

 - Miramar Commander Col. T.M. Bedell could not attend due to illness so updates were provided by Kristin Camper
 - Col Bedell is working to continue his program of training marines to aid in fighting wildfires that occur on base
 - The barracks need improvement as has been reported in the press but the Miramar barracks are not the worst of the marine bases
 - Current efforts are focused on thorough move-in and move-out inspections
 - Col Bedell will be replaced by Col Robert Hermann in July 2024
 - Tree and brush removal at base boundary needs to be coordinated with the city to clarify boundaries of federal land and city land
 - The MCAS Miramar is working to transfer the Stowe Trail to the county. Currently access is allowed via permit. Info here:

Info Item 2: Non-agenda Public Comment

- Bob Lang read an email he received from a local Boy Scout who wanted to know what is being done about homelessness in Tierrasanta and what the boy scouts can do to help
 - Discussion about number of homeless in Tierrasanta canyons (very few)
 - Discussion that being homeless is not a crime, but the potential safety issues, like fires need to be address

Info Item 3: Rodrigo Mora of Anytime Fitness Rodrigo.Mora@anytimefitness.com introduced himself and described his plans to open an Anytime Fitness in Tierrasanta to be located at 10601 Tierrasanta Blvd, San Diego, CA 92124. Since the business will be operated 24 hours a day, he is working with the city to permit this appropriately and wanted to inform the community of his plans.

- Rodrigo grew up in San Diego and went to college in Texas. He became involved in Anytime Fitness while living in Texas and decided to return to San Diego and start new locations here. He and his wife own an Anytime Fitness location in El Cajon and the success of that location and their research into Tierrasanta suggest that an Anytime Fitness club would do well here.
- A little about the business:
 - Anytime Fitness is the largest chain int eh world with 5000 locations worldwide but are all independently owned.
 - They operate a very personalized fitness model. All members are known by club management/staff on a first-name basis. Each member is partnered with a trainer so that programs can be customized to fit the needs of the member. The club is inclusive with programs for seniors and members as young as 16 years old.
 - The business is open 24 hours but only has personnel on-site during the day (not staffed 10 7 am) Monday through Friday and Saturday morning. There are security cameras that monitor who accesses the facility and when. Mr. Mora has not had security issues at his other location.
 - Mr. Mora is hoping to open the new location in August 2024 if he can get the permits and the construction completed
- Discussion about parking for the facility and concerns about cars coming late at night.
 - Mr. Mora's response: Although the club could have up to about 1000 members, only about 300 are expected to attend the gym regularly. When you consider that these members will spread their attendance over the week/day, it works out to about 15 people during peak hours.
 - The club will have 15 devoted parking spaces and additional parking is available elsewhere in the shopping center (shared with other businesses)
 - People rarely attend the gym between midnight and 3 am.
 - The gym has a landline and special emergency contact systems to help maintain safety when club personnel are not on-site
- Next step for approval: City of San Diego will request that the TCC to vote on whether to approve Anytime Fitness as a 24-hour business in Tierrasanta

 - Dawn Nielsen-Lostritto: One of the most important/impactful things that the TCC does is host these concerts every summer. This summer there will be 6 concerts on Saturdays, starting June 29 through August 3. This year John Sperrazzo would like to receive a stipend in exchange for managing these events. Normally, these events are completely volunteer run, but having 6 concerts is unwieldy. There will be a vote to decide if we should pay the stipend. Other updates: it looks like there will be porter potties this year to help with the toilet situation. The concerts will require a large group of volunteers to help with setup, cleanup, and parking.

 - No updates, however, Dawn Nielsen-Lostritto recommended that anyone who
 has not had the chance to attend should attend a CPC meeting. They are quite
 interesting events and let you see the challenges faced by communities around
 San Diego.
- Miramar Community Leaders Forum: Don Chick
 - No update
- Tierrasanta Recreation Council Liaison: Rich Thesing
 - Rich Thesing: He has received no complaints. A compromise to allow pickleball players to use the rec center tennis courts is in the works. The tennis courts are part of San Diego Parks and Recreation so should be open for public use. Raul Campillo's office is helping with the negotiations.
- Mission Trails Regional Park Liaison: Rich Thesing, Dawn Nielsen-Lostritto, Ingrid Cornax
 - The proposed new pedestrian bridge (near Jackson) is 1000 feet long, 130 feet high, 8 feet wide, and good for 100-year flood conditions. A potential problem is that it may impose on nature and/or interfere with bird flyways.
 - During the MCAS Miramar presentation, the county is working on acquiring land to allow for a path (currently the Stowe trail) to connect Poway to Mission Trails

 - Three people likely drowned due to flooding during the winter storms this year.
 Most unhoused people willingly moved away from the river before the storms occurred and some of them have now returned.

 - Ready-mix Conditional Use Permit (CUP) is now being reviewed by the city.
 Superior will be giving a presentation on the CUP during the next meeting in April
- Open Space Committee: Bob Lang, Rich Thesing, Jennifer Schultz
 - Meetings occurring at Tierrasanta Library which will be closing for repairs for May and June. Last meeting, Guest Speaker from Allied Gardens talked about how they established a dog park. This was accomplished with great support from Councilmember Raul Campillo. Surprisingly, very few attendees to meeting.
