CALL TO ORDER

Jesus Benayas noted the 50th anniversary of Martin Luther King's assassination. Next year is the 500th anniversary of the assassination of Vasco Nunez de Balboa. Mr. Benayas told the Balboa Park Committee they were being ignorant of history, and were not bringing the community together due to greed, power and hate, and that the Committee has done the Mayor, City Council and Community a disservice.

CHAIRPERSON'S REPORT

Chairperson Johnston sought input regarding the non-profit updates given monthly which are of great value and exploring other frequencies of reports that might be helpful such as quarterly reporting to ensure that business of the committee is addressed and that the meetings conclude in a timely manner.

• Many projects have long time frames and overlap is substantial, however quarterly may be too long, it should be based on urgency or importance.

Molly Chase, City Council Third District reported the following:

- Budget season is beginning April 13
- Councilmember Ward is advocating for Park and Recreation to keep the Department whole and looking at implementation of the General Park Plan
- New restrooms are funded on the West Mesa and exploring funding for minor improvements
- Requesting additional night time patrols of park by the Police Department
- Council approved a new storage facility in Sherman Heights to assist the homeless which should open by July

Mario Llanos, District Manager, Balboa Park Operations, reported the following:

- Last Month we finished the mulching and fertilizing of the Rose Garden with the Rose Corps. Please take a moment to stop by and check out the Rose Garden, it is loaded with blooms.
 - 157 transients contacted throughout balboa park (illegal lodging, encroachment, drinking, smoking, disturbances and sleeping in the comfort stations) This resulted in 12 citations being issued (Smoking, illegal lodging, encroachment, tents, destruction of plants, glass containers)
 - Three cleanups with the Environmental Services Department were conducted at Golden Hill Park (24th and Russ), Florida Canyon (Morley and Florida), Nate's Point (Adjacent to dog park)

A motion was made by Ms. Schiavoni and seconded by Ms. Kanzawa to approve staff's recommendation, requesting that the Park and Recreation Director extend a waiver to the summer moratorium for the ESRI event. The motion was unanimously approved (8-0).

302. 2018 American Heart Association – San Diego/Balboa Park – Heart and Stroke Walk

Susan Lowery-Mendoza noted the issues raised at their 2017 event regarding noise – pre-event and day of event, equipment left behind and start time. Amanda Ferguson of the American Heart Association noted the benefits of the walk which allows them to run programs for healthier living, provides over 12 million invested in research in San Diego, raised \$1.1 million in 2017 with 10,000 participants and is appreciative to Balboa Park for hosting the event. She introduced Mr. David Flourney of Renegade Racing, event organizer who noted that they are changing their event layout with a 50 ft. setback from the sidewalk, implement sound monitors, working with Caltrans to start the event later at 7:45 a.m., and ensure that all equipment is removed from the park.

- Thanked organizer for taking community complaints seriously

INFORMATION ITEMS

501. Palm Canyon Honeymoon Bridge Reconstruction, Presenter: Mr. John Bolthouse, Executive Director, Friends of Balboa Park

Mr. John Bolthouse, Executive Director of the Friends of Balboa Park presented a conceptual idea of recreating the Honeymoon Bridge also known as the Sweetheart Bridge or Rustic Bridge across Palm Canyon. He provided the history of the 150 foot long bridge designed by Richard Requa that used log trusses. The original cement stairs and landings still remain today. The Friends of Balboa Park are in the exploratory phase of this project.

- Asked about estimated cost (only have rough estimate)
- Inquired about materials used (steel clad with wood)

502. DecoBike Stations in Balboa Park, Presenter: Mr. Don Liddell, West Mesa Subcommittee Chair

Mr. Liddell noted that the West Mesa Subcommittee has brought forward public safety concerns for pedestrians and special events. The rack is located a distance away from the crosswalk. The advertisements on the stations inside the park also are not consistent with park plans, but are able due to special agreement with the City.

503. Velo Youth Program, Presenters: Mr. Jim Benedict, Mr. Matt Hoffman, and Ms. Tanya Landry.

Mr. Benedict presented an overview of the good work being done by the Velo Youth program at the Velodrome in Balboa Park which is both exciting and impactful for atrisk youth. They have been working primarily with 120 – 140 Monarch School and Hoover High School students over the course of the last ten years. He encouraged all to visit their website to view their PSA and on online articles to see how they are improving the lives of local youths.
