301. Reader Tacotopia. Presenter: Ashley Naugle, San Diego Reader

Requesting use of Golden Hill Park on Saturday, May 14, 2016 from 12:00 P.M. to 4:00 P.M. for an event benefitting the Great Golden Hill Development Corp. Event will feature over 30 food booths, a beer and spirits garden and vendor area. Estimated attendance is 2,500. Event was approved in 2015 as a one- time event.

Staff Recommendation: To approve this event as presented.

302. San Diego Maker Faire. Presenter: Peter Comiskey, Balboa Park Cultural Partnership, Executive Director

Requesting use of the Federal Lawn, Recital Hall Lawn, El Prado, Cascades, Plaza de Balboa (Bea Evenson Fountain area), northern half of the Organ Pavilion Parking Lot, and the southern half of the Palisades Parking Lot on September 29 – October 3, 2016 (event days October 1 -2 from 10:00 A.M. – 5:00 P.M.) for paid admission attractions with inter-active displays and beer garden.

Staff Recommendation: To approve the outdoor venues as requested to coincide with the museum's indoor maker activities.

303. 30th Philippine Cultural Arts Festival. Presenter: Patrick Ambrosio, Event Organizer.

The Samahan Filipino American Performing Arts & Education Center is requesting a change of event date, June 25 - 26, 2016 to coincide with the date of the passing of Ray Aragon, a Filipino community leader. Event is traditionally held on the second weekend in August and uses the lawn at Park and President's for a two day event. Estimated Attendance is 2,000.

Staff Recommendation: To approve this one-time (2016) date modification for the annually-held event.

304. Heart and Stroke Walk, American Heart Association/American Stroke Association. Presenter: Annie Garcia, Sr. Business Development Director, Heart & Stroke Walk

Requesting use of the festival site and walk route on Saturday, September 17, 2016 approved in 2015. Set-up to begin on Friday, September 16 at 8:30 a.m. Event had traditionally been held on the 2nd Saturday in September at the War Memorial Lawn with a route that proceeded by the Zoo and parking garage affecting Zoo operations. In 2015, the festival area and start/finish was relocated to 6th and Laurel Street South Lawn, with a survivor's route (shortened) and 5k walk route starting on El Prado heading East, South on Pan American Road, East on Presidents Way, South on Park Blvd, Right onto 163 North exiting to Westbound Robinson Ave, South on 6th Ave, South on Balboa Dr. to the finish. It is estimated that all impacted roads will re-open by 10:00 A.M. Estimated attendance is 10,000.

Staff Recommendation: Recommend approval of the festival location and walk route with shuttle service to Inspiration Point parking lot.
