101. March for Babies. Presenters: City Staff and Event Organizers

Event is traditionally held on the West Mesa at 6th and Laurel. Organization is requesting a venue change to accommodate a drive through event in the Lower Inspiration Parking Lot on Saturday, April 24, 2021 from 7:00 a.m. - 2:00 p.m. (including same day set-up and break down.) Estimated attendance is 500 vehicles. Drive through events require a Special Event Permit which will include traffic control.

Staff Recommendation: To approve this one-time venue change due to COVID impacts on events.

102. Third Annual Scoop San Diego Ice Cream Festival. Presenters: City Staff and Event Organizers.

This new event is requesting use of the Lower Inspiration Parking Lot on Saturday, May 22, 2021 for a drive through event from 8:00 a.m. - 8:00 p.m. (including same day set-up and break down.) Estimated attendance is 875 vehicles with timed entry tickets. Drive through events require a Special Event Permit which will include traffic control.

Staff Recommendation: To approve the event on a one-time basis due to lower anticipated attendance in the park.

103. New School of Architecture and Design Graduation. Presenters: City Staff and Event Organizers.

This new event is requesting a onetime use of Lower Inspiration Parking Lot on Saturday, June 19, 2021 for a drive through graduation celebration from 8:00 a.m. - 1:00 p.m. (including same day set-up and break down.) Estimated attendance is 100 vehicles.

Staff Recommendation: To recommend that the Parks and Recreation Director extend a one-time waiver of the Summer Moratorium for this event due to COVID impacts on events.

104. Art Alive, Open Air Floral Affair. Presenters: City Staff and Event Organizers.

Requesting a waiver to the summer moratorium for use of the Plaza de Panama June 14 - 21, 2021 (including set-up and break down.) The event is traditionally held in April and many of the event components were held inside the museum. Estimated attendance is 8,000 over the course of the three-day event.

Staff Recommendation: To recommend that the Parks and Recreation Director extend a one-time waiver of the Summer Moratorium for the 2021 Art Alive Event due to COVID impacts on this traditional event.
