SUBJECT: San Diego Museum of Art Display of Calder Artwork

## SUMMARY

Issue - Should the Balboa Park Committee recommend approval of the extended display period for the Calder sculpture at the San Diego Museum of Art?

Department Recommendation - Recommend approval of the extended display period for the Calder sculpture at the San Diego Museum of Art.

Other Recommendations - None
Fiscal Impact - Funding for installation, maintenance and de-installation of the artwork will be the responsibility of the San Diego Museum of Art.

Environmental - This activity is categorically exempt from CEQA pursuant to State CEQA Guidelines Sections 15311 (c), Accessory Structures, and Section 15331, Historic Resource Restoration/Rehabilitation.

## BACKGROUND

The San Diego Museum of Art (SDMOA) is located on the north side of the Plaza de Panama in the center of Balboa Park. The main building was constructed in 1926 as the Fine Arts Palace and has served as an art museum ever since (with the exception of Naval Hospital occupation during the 1940 's). The building was designed by renowned Architect William Templeton Johnson, and is a contributing element to the Park's National Historic Landmark District.

In June of 2009 the SDMOA installed an artwork titled "Spinal Column" by Alexander Calder. Staff subsequently informed the SDMOA of the requirements for displaying artwork in public spaces. While the artwork is located within the SDMOA leasehold, it is in an area readily visible to the public and considered a public space. An application was then processed through the City's Commission for Arts and Culture for a temporary display of the artwork. The Balboa Park Committee was notified as an information item in September of 2009.

In accordance with the original permit the artwork was to be installed from June 28, 2009 to June 14, 2010. That date has lapsed, and the SDMOA wishes to extend the exhibit to June 14, 2012.

The City of San Diego Municipal Code, Chapter 2, Article 6, Division 7, Article 26.0722 specifies no artworks shall be contracted for, exhibited on or erected on public spaces without review and approval by the Commission for Arts and Culture and staff. Commission for Arts and Culture staff have a Department Instruction (DI) that extends the review process to Park and Recreation staff and its advisory bodies when the artwork is to be located on park land. Park and Recreation staff consults with Historic Resources staff and Environmental Analysis Section staff as appropriate for the proposal.

## DISCUSSION

The artwork has been on display since June of 2009. No additional work or physical impact to the Park is required to continue the exhibit. Upon de-installation the SDMOA will be responsible for restoring the site back to its original condition, which will entail patching of holes in the pavement used to secure the artwork.

Historical Resources staff has reviewed the proposal and has no issues provided the artwork is de-installed on the date specified in the application to the Commission for Arts and Culture (June 14, 2012).

This proposal will be reviewed by the Park and Recreation Board with final recommendation to the Commission for Arts and Culture.

## ALTERNATIVES:

1. Do not recommend approval of the extended display period for the Calder sculpture at the San Diego Museum of Art.
2. Recommend approval of the extended display period for the Calder sculpture at the San Diego Museum of Art with conditions.

## Description of exhibition

Spinal Column was installed on the front steps of the Museum after having been on loan to the Museum of Contemporary Art San Diego, which displayed it on a low plinth on the corner of Kettner and Broadway until early 2008. Upon receiving the work back from its downtown public display by MCASD, the Museum of Art conducted a major conservation treatment on the work.

The installation on the front steps of the Museum was scheduled to:

1) coincide with The Year of Modern Art, which includes our temporary exhibitions, Calder Jewelry (on view until 3

January 2010) and Picasso, Miró, Calder (on view until 6 December 2009;
2) celebrate the recent conservation of the artwork; and
3) celebrate our upcoming major installation inside the Museum of our permanent collection of $20^{\text {th }}$-century art from around the world, a collection that has been largely off view for the last 10 years.

Spinal Column was purchased in 1968, the year in which it was made, from the artist by Norton and Barbara Walbridge, who were among the institution's most important donors of $20^{\text {th }}$ century art. Spinal Column was given to the Museum with

The work was installed by museum staff and conservators on 28 June 2009 and is scheduled to be in this location until 14 June 2010. This timeframe coincides with the Museum's Year of Modern Art exhibition program outlined above.
