201. Recommendation on the proposed amendments to the Balboa Park Master Plan and Central Mesa Precise Plan, and Site Development Permit to implement the Plaza de Panama, Circulation and Parking Structure Project.

301. <u>Father Joe's Thanksgiving Day 5K</u> – Rick Kozlowski, KOZ Enterprises representing Saint Vincent de Paul Village Requesting to change the route traditionally used for the 5K on Thursday, November 22, 2012 to allow for continued growth of the event. The route will start on the Cabrillo Bridge at 8:00 A.M. and end on El Prado at the Lily Pond at 9:30 A.M. (course narrative attached).

Staff Recommendation: To approve the route change as the majority of the Park institutions are closed on Thanksgiving Day and San Diego Zoo is supportive of change.

302. ESRI User Conference Party – Allison Rynne, Audacity Events Requesting a waiver to the Summer Moratorium to use a portion of Balboa Park to host the ESRI User Conference Party on Thursday, July 26, 2012 from 5:30 P.M. – 9:30 P.M. Approximately 8,000 guests will be transported to the Park via motor coach from the San Diego Convention Center and contracts are being pursued with: the San Diego Museum of Art; San Diego Natural History Museum; the Reuben H. Fleet Science Center; the Museum of Photographic Arts; the San Diego History Center; the San Diego Model Railroad Museum; and the House of Hospitality (with The Prado providing catering services). The San Diego Hall of Champions staff will be providing support during the event. Requested Park use includes: twenty (20) parking spaces behind the Casa de Balboa for catering truck parking; six (6) parking spaces behind the Botanical Building for dumpster placement; six (6) parking spaces behind the Rueben H. Fleet Science Center; use of both Botanical Building lawns included erection of fencing, Cascades and the Casa del Prado Patios for food and beverage service; and placement of entertainers with amplification on El Prado, Cascades and the Botanical Building Lawns.

Staff Recommendation: To request that the Park and Recreation Director extend a waiver to the Summer Moratorium for the ESRI event in 2012 with the following changes; fencing only of the East Botanical Lawn and no amplification of the entertainers on El Prado from the Cascades to the Plaza de Panama.
