201. House of Pacific Relations International Cottages Plan Amendment Initiation Presenters: Charles Daniels, Park Designer, Park and Recreation Department and Vicki Estrada, Estrada Land Planning

301. San Diego Road Race Centennial Living History Car Show, Newell Booth – La Jolla Regional Group of the Horseless Carriage Club of America

Requesting use of 60 parking spaces for a car show in the Palisades North Parking Lot, occupying four rows of parking just north of the tram stop from 8:00 a.m. – 5:00 p.m. on Saturday, January 10, 2015. The car show will include a tour out the park to retrace the route of the San Diego Exposition Road Race from 10:00 A.M. – 11:30 A.M. Estimated attendance is 1,100 throughout the day.

Staff Recommendation: To approve this one –time event as presented in 2015. Institutions bordering Pan American Plaza have been consulted for planned use and there are no other major events in the park.

302. 34th Annual Tribute to the Legends Festival, Makeda Cheatom – Executive Director and Jesse Graham, Manager, World Beat Cultural Center

Requesting use of the Cultural Turf East, located between the World Beat Cultural Center and the Centro Cultural de la Raza on February 14-16, 2015 and 45 parking stalls for event vendor staging in the Upper Inspiration Parking Lot for a musical tribute festival (concert dates are February 14 and 15 from 5:00 P.M. to 12:00 A.M.) The entire venue, including the World Beat Center will be fenced and an 80' x 100' tent erected on the lawn. Estimated attendance is 1,000 per day.

Staff Recommendation: To approve this one- time event as presented in 2015. Tenting and fencing of venue require extensive coordination with the Police and Fire Departments to ensure public safety and regulatory compliance.

303. San Diego Maker Faire, Sue Varga, Director Balboa Park Marketing/Conservancy and Travis Good, Consultant

Requesting use of the Federal Lawn, Recital Hall Lawn, House of Pacific Relations Lawn, Palisades Lot South, El Prado, Botanical Lawns East and West, Cascades, Plaza de Balboa (Bea Evenson Fountain area) and the Plaza de Panama (if available for permitting) on October 2-4, 2015 (event days October 3 and 4 from 10:00 A.M. -6:00 P.M.) for free, passive entertainment and displays, creating an event presence throughout the park.

Staff Recommendation: To approve this park-wide event as many park institutions are participating, the majority of activity is occurring within the institutions and there is minimal impact on parking and access.

304. Suja Rock 'n' Roll San Diego 5K, Kara Kong, Community Relations Manager-Competitor Group

Requesting a waiver to the Summer Moratorium to add a 5K run in Balboa Park on Saturday, May 30, 2015. Race to be start at 7:00 A.M. at 6th Avenue at Palm and finish on Balboa Drive at the equivalent of Olive. Anticipated attendance is 3,000 and the Cabrillo Bridge is expected to be open to vehicular traffic at 9:00 A.M. Staff Recommendation: To request that the Park and Recreation Director extend a waiver to the Summer Moratorium for the San Diego Rock 'n' Roll 5K.
