Requesting a venue location change and walk route on Saturday, September 19, 2015. Event has been traditionally held on the 2<sup>nd</sup> Saturday in September on the War Memorial Lawn with a route proceeding South on Zoo Drive past the Zoo entrance, South on Village Place, West on El Prado, South on Balboa Drive around the Marston Loop, following the same route back to the War Memorial Lawn. For 2015, the festival area and start/finish is proposed for the 6<sup>th</sup> and Laurel Street South Lawn, with a survivor's route (shortened) and 5k walk route starting on El Prado heading East, South on Pan American Road, East on Presidents Way, South on Park Blvd, Right onto 163 North exiting to Westbound Robinson Ave, South on 6<sup>th</sup> Ave, South on Balboa Dr. to finish. It is estimated that all impacted roads will re-open by 10:00 a.m. Estimated attendance is 8,000.

Staff Recommendation: Recommend approval of the new festival location and walk route which provides the required grade for the Survivors' Walk and will no longer impact the San Diego Zoo's operations and parking.
