# **CULTURAL PARTNERSHIP PROGRAM UPDATES**

Michael Hager reported the following:

- The 2011 Balboa Park Sustainability kickoff will begin on Thursday, January 27 with a session on How to manage your business's energy costs. The program will be held in the Museum of Photographic Arts from 8:00 A.M. to 3:00 P.M.
- On Wednesday, March 23, the first session of the Sustainability Workshop Series will be held from 9:00 A.M. to 3:30 P.M.
- Mr. Hager recognized the Balboa Park Sustainability Program which has been awarded 2 million in Energy Efficiency Conservation Block Grants for 30 energy efficiency projects. Over \$200,000.00 will be saved annually and emissions will be lessened.

# **WORKSHOP ITEMS**

**401.** Balboa Park Plaza de Panama Circulation and Parking Structure Project – Mark Johnson

#### **Public Comments:**

- Bruce Coons of Save Our Heritage Organisation presented a brief DVD presentation noting: images of the past; damage since 1917 of the historic fabric by automobiles; the garage will bring more vehicles into the Park; the bypass bridge will ruin the view and destroy the character of the area. He is in favor of removing the vehicles from the Plaza and starting with the historic plan of the Spanish Colonial style as it is part of the National Historic District.
- Jay Shumaker remarked that the top down tour should remain. The European plazas are 50 yards x 80 yards and plazas larger than that are empty and hot in the middle. He suggested building the garage first, then the plaza. Don't alter the bridge traffic for the plaza.

#### Presenter's Comments:

- Mr. Johnson of the design team noted that they are charged with balancing the project, not to interpret Bertram Goodhue's plan of 100 years ago, as the current needs are different than those of 1915.
- Mr. Johnson noted a change in the process now, to begin conversation about what should happen in the Plaza and the Esplanade. He reviewed the issues brought forth by the Planning Commission and described the connection to the bridge.
- David Marshall noted that tables are set-up in the back of the room for feedback of the three key elements, the bypass bridge, the parking structure and the Plaza de Panama. The project will be reviewed by three historic oversight groups at the local, state and federal level and the project will go through the public process.

Chairperson Kinney called the meeting back to order at 7:50 p.m. and thanked the consultants. He asked everyone to attend the January 8, 2011 meeting to continue to provide input on the project.
