Appointment and Reappointments to the Accessibility Advisory

Board

I am appointing Dr. Letty Zuno and reappointing Patricia Sieglen-Perry, Wayne Landon, Jaqueline Jackson to the Accessibility Advisory Board.

Dr. Zuno serves as the Executive Director of Access to Independence of San Diego, Inc. for the last 15 years. In this role, she works with individuals with a wide range of disabilities on their pursuit for independence. Dr. Zuno holds a Bachelor of Arts in English and French Literature, a master's degree in Governance and Leadership, and a Juris Doctorate in Legal Advocacy. She is being appointed to a two-year term ending June 30, 2025 in the ADA Expert Seat.

Ms. Sieglen-Perry has worked for over 25 years in the field of disability and has specialized in deafness for most of her career. She started with Deaf Community Services (DCS) as a counselor and was eventually selected as its Executive Director. In that role, she incorporated the agency, established a deaf majority board of directors, and expanded the services and scope of the non-profit. Ms. Sieglen-Perry has a master's degree in Rehabilitation Counseling from San Diego State University. She is being reappointed to a two-year term ending June 30, 2025, in the ADA Expert seat.

Mr. Landon has served as Government Relations Director for the Cal-Diego Chapter of the Paralyzed Veterans of America (PVA) for the past 16 years. He served three years in the U.S. Army and, in 1990, graduated from the University of Montana with a Bachelor of Arts in Social Work. He worked over four years as a Transitional Counselor for the Fort Belknap Indian Community College in Montana and then moved to San Diego, where he was employed by

Cal-Diego PVA. Mr. Landon is being reappointed to a two-year term ending June 30, 2025, in the ADA Expert seat.

Ms. Jackson has over thirty years of professional work experience in the nonprofit/social services sector. For several years, she worked as the Director of Employment Services for San Diego's Independent Living Center, Community Service Center for the Disabled. She is a proud member of Webster Community Council and was unanimously elected as the first consumer chairperson for San Diego County In–Home Supportive Services Advisory Committee. Ms. Jackson has served as an appointee to the Governor's Committee for the Employment of People with Disabilities and served on the State Superintendent's Ethnic Advisory Committee. Ms. Jackson received her bachelor's degree from San Diego State University and her master's degree in Education Leadership with a specialization in Nonprofit Business Management from the University of San Diego. She is being reappointed to a two-year term ending June 30, 2025, in the ADA Expert seat.
