## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## SPECIAL EVENTS DEPARTMENT

**PROJECT NAME:** Special Event Permit - Play Day at the Lake **COMMUNITY PLAN AREA:** Mid City – Eastern Area **COUNCIL DISTRICT:** 4 **LOCATION:** Chollas Lake Park, 6350 College Grove Drive

**PROJECT DESCRIPTION:** Special Event Permit for a community event that would include kid activities, vendors, food, food trucks, a stage, a petting zoo, entertainment, and the temporary use of onsite food preparation, canopies, generator, portable restrooms, trash/recycling containers, tables and chairs that would occur at Chollas Lake Park, easternmost parking lot is the main activity site, and would be completely closed to public parking on June 8, 2024. Noise associated with the event activities and set-up/dismantling would occur from 6:30 AM until 5 PM on June 8, 2024. On June 8, 2024, set-up would occur from 6:30 AM until 11 AM, the event would occur from 11 AM until 4 PM, and dismantling would occur from 9 AM until 5 PM. There would be a stage with entertainment and sound amplifications would occur from 9 AM until 4 PM. Approximately 1,000 attendees are anticipated throughout the course of the event.

A parking lot closure would be associated with the event and would occur on June 8, 2024, from 6:30 AM until 5 PM, and would include the easternmost side of the parking lot closed to public parking, along with parking spaces on the north side of College Grove Drive.

There would be no road closures associated with the event.

## ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
