NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - Horizon Music 2024

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: County of San Diego Water Park at the Embarcadero, Harbor Drive, Access Road, Grape

Street, Pacific Highway, Ash St (see attached maps)

PROJECT DESCRIPTION: Special Event Permit for lane, sidewalk, and road closures within the City of San Diego's right-of-way jurisdiction that would be associated with a two-day music festival that would occur at the County of San Diego Waterfront Park at the Embarcadero on April 6, 2024. The event permit would be issued by the County. Noise associated with the event activities and set-up/dismantling would occur from 6 AM on June18, 2024, to 1 PM on June 25, 2024. Set up would occur over four days: on June 18-21, 2024, from 6 AM to 11:55 PM. The event would occur on June 22, 2024, from 3 PM to 11 PM, and on June 23, 2024, from 2 PM to 10 PM. Dismantling would occur from 1 AM to 11:55 PM on June 24, 2024, and on June 25, 2024. from 1 AM to 1 PM.

See attached maps for all closures. Road closures and parking closures associated with the event would include Frontage Road between W. Hawthorn to W. Grape Street, and the 3rd lane on Harbor Drive between Ash and Grape Street (northbound) from 12:01 AM on June 18, 2024, until June 25, 2024, at 1 PM, along with the bike lane on N. Harbor Drive between Ash and Grape Street.

Parking would be prohibited and would include the N. Harbor Drive parking meters between Ash and Grape Street, Frontage Road east of Harbor Drive between Grape and Hawthorne, and south curb of Grape Street parking meters between Pacific Highway and Harbor Drive from 12:01 AM on June 18, 2024, until June 25, 2024, at 1 PM; Pacific Highway parking meters between Grape and Ash Street from 12:01 AM on June 22, 2024, until June 23, 2024, at 11:55 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.
