NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit - San Diego Black Arts + Culture District Music Festival

COMMUNITY PLAN AREA: Encanto

COUNCIL DISTRICT: 4

LOCATION: Martin L. King Memorial Park, 6401 Skyline Drive, San Diego, CA 92114

PROJECT DESCRIPTION: Special Event Permit for an art and music festival event that would include the temporary use of a stage, entertainment, sound amplification, food, onsite food preparation, food trucks, non-alcoholic beverages, tents, fencing and/or barriers, generator, tables, chairs, portable restrooms, recycle/trash containers, to occur at Martin L. King Memorial Park on June 29, 2024. Noise associated with the event activities and set-up/dismantling would occur from 10 AM on June 28, 2024, until 1 PM on June 30, 2024. There would be a stage with entertainment and sound amplification would occur from 10 AM until 9:30 PM. On June 28, 2024, set-up would occur from 10 AM until 5 PM. The event would occur from 7 AM until 10 PM on June 29, 2024. And dismantling would occur from 9 AM until 1 PM on June 30, 2024.

A parking lot closures would be associated with the event and would occur from 10 AM until 10 PM on June 29, 2024, and would include the park parking lot located at the northern portion of the park, adjacent to the softball fields.

There would be no road closures associated with this event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or

no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The completed appeal form shall include the required appeal fee, with a check payable to: City Treasurer.
