201. **Fiscal Year 2024 Mission Bay Park Improvement Funds Reallocation** Ryan Barbrick, Program Manager, Parks and Recreation requested the Mission Bay Park Improvement Fund Oversight Committee approve the recommendation to reallocate \$2,186,956.00 of Mission Bay Park Improvement Funds in audited revenues received to the following projects:

- Ventura Comfort Station Improvements, CIP# B18227 \$200,000.00
- South De Anza Basketball Courts and Play Area, CIP# B19173- \$1,100,327.00
- Dusty Rhodes Parking Lot Improvements, CIP# B19158 \$586,629.00
- Crown Point Playground Improvements, CIP# B19021 \$300,000.00

Funding will come from the following projects:

- \$139,823.36 from B19177 Bonita Cove East Comfort Station. This project was placed on hold during the pandemic due to a revenue shortage. It will remain on hold. Once funding is available, the project can restart design.
- \$226,916.72 from B19178 Bonita Cove East Playground. This project was placed on hold during the pandemic due to a revenue shortage. It will remain on hold. Once funding is available, the project can restart design.
- \$357,709.00 from AGF00004 Mission Bay Improvements from project savings.
- \$502,506.92 from B22039 Bahia Parking Lot and Comfort Station. This project will be put on hold. It was early in design. Once funding is available, the project can restart design.
- \$750,000 from B18223 Adult Fitness Course East Shore. This project is closing and has project savings.
- \$160,000.00 B19029 Santa Clara Playground Improvements. This project is closing and has project savings.
- \$50,000.00 from B19032 Santa Clara Comfort Station Improvements. This project is closing and has project savings.
