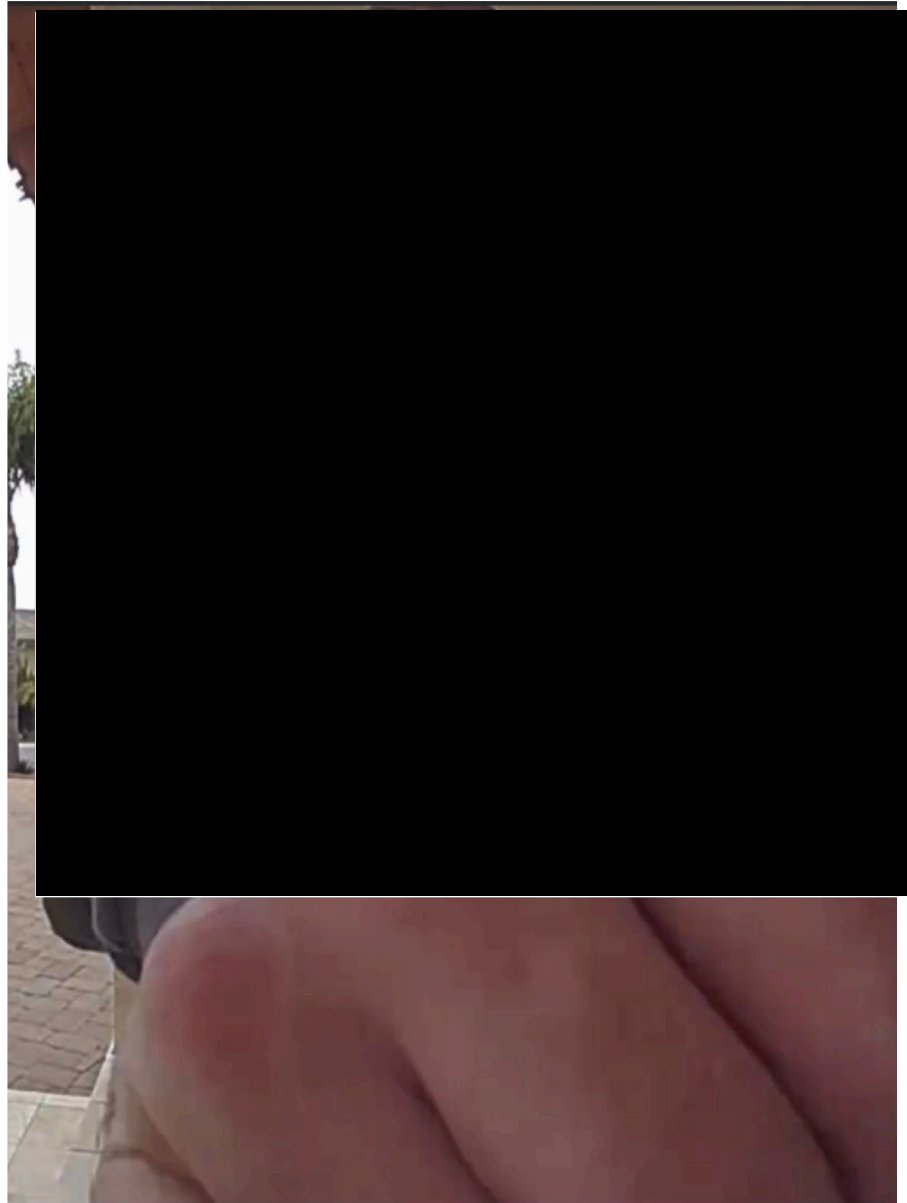

Signage Proposal

- ▶ Standardize prohibition IAW San Diego Municipal Codes
 - ▶ Municipal Code Ordinance 63.0102(b) with following subsections and their prohibition:
 - ▶ (3) Fireworks
 - ▶ (7) Glass Containers
 - ▶ (8) Littering
 - ▶ (11) Fires
 - ▶ (16) Conduct
 - ▶ “It is unlawful to engage in any indecent conduct or indulge in any riotous, boisterous or threatening behavior.”

Signage Proposal (cont'd)

- ▶ Standardize prohibition IAW San Diego Municipal Codes (cont'd)
 - ▶ Municipal Code Ordinance 43.1002(g) Smoking
 - ▶ “It is unlawful to *smoke* or *vape* in a *public park* or *public beach*, on a *boardwalk*, *seawall*, *City-owned fishing pier*, or on the *Cabrillo Bridge* in Balboa Park, except in a temporary or permanent area authorized by the City of San Diego that is clearly demarcated by signs in conformity with this Division.”
