ELECTION NOTICE

June 14, 2024

Notice is hereby given of the impending election of a SPSP, SPSP-H, or 401(a) Plan Trustee to serve as a member of the Defined Contribution Plans Trustee Board for the 2024-2027 term. Nomination Petitions for candidates must be filed with the Risk Management Department, Employee Savings Section, no later than June 28, 2024. The candidate must meet the following conditions and qualifications:

1. The candidate must have completed his or her probationary period of employment and currently be contributing to the SPSP, SPSP-H, or 401(a) Plan.
2. The nomination petition must be signed by no less than ten (10) active (currently making contributions) SPSP, SPSP-H, or 401(a) plan participants and returned to Retirement@sandiego.gov **no later than 5:00 p.m. on June 28, 2024.**

It should be emphasized that the Trustee is expected to serve the entire 3-year term, to participate in all Trustee meetings (quarterly, with special meetings when needed), and to accept additional committee work assignments as necessary from time to time. It is therefore vital that each candidate have sufficient time to properly fulfill the obligation accepted by all members of the Trustee Board. Trustees do not receive any compensation.
