# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - San Diego Pride Parade & 5K 2024

**COMMUNITY PLAN AREA:** Balboa Park

**COUNCIL DISTRICT:** 3

**LOCATION:** University Ave., 6th Ave., Balboa Dr., Normal St. (see attached map)

**PROJECT DESCRIPTION:** Special Event Permit for a parade and 5K event that would include vendors, a parade, floats, cars, animals, food vendors, food trucks, onsite food preparation, entertainment, music, a stage, tents/canopies, fencing and/or barriers, tables, chairs, portable restrooms, and trash/recycling containers, and would occur on July 20, 2024, on University Ave, 6th Ave. and Balboa Drive as shown on the attached map. Noise associated with the event activities and set-up/dismantling would occur from 4 AM until 4 PM on July 20, 2024. There would be a public announcement system used and sound amplification would occur on July 20, 2024, from 8 AM until 4 PM. Set-up would occur from 4 AM until 8 AM, the event would occur from 8 AM until 3 PM, and dismantling would be a rolling clean up as the parade and run ends through 4 PM. The parade and 5K routes are shown on the attached map.

The following road closures associated with the event would occur from 5 AM until 4 PM on July 20, 2024:

Centre Street between University Avenue and Park Boulevard;  
Normal Street between Washington Street and University Avenue;  
Cleveland Avenue between Richmond Street and Washington Street;  
Harvey Milk Street between Cleveland Avenue and Centre Street;  
Lincoln Avenue between Washington Street and Park Boulevard;

The following road closures associated with the event would occur from 6:30 AM until 4 PM on July 20, 2024:

University Avenue between 5th Avenue and Park Boulevard;  
Herbert Street between University and Robinson Avenues;  
Essex Street between Herbert and Richmond Street;  
6th Avenue between University Avenue and Upas Street;  
Robinson Avenue between 5th Avenue to 6th Avenue;  
Evans Place between 5th Avenue to 6th Avenue;  
Pennsylvania Avenue between 5th Avenue to 6th Avenue;  
Anderson Place between 5th Avenue to 6th Avenue;

Ivy Lane between 5th Avenue to 6th Avenue;  
Upas Street between 5th Avenue to 6th Avenue;  
Balboa Drive in Balboa Park between 6th Avenue and Upas Street to El Prado

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

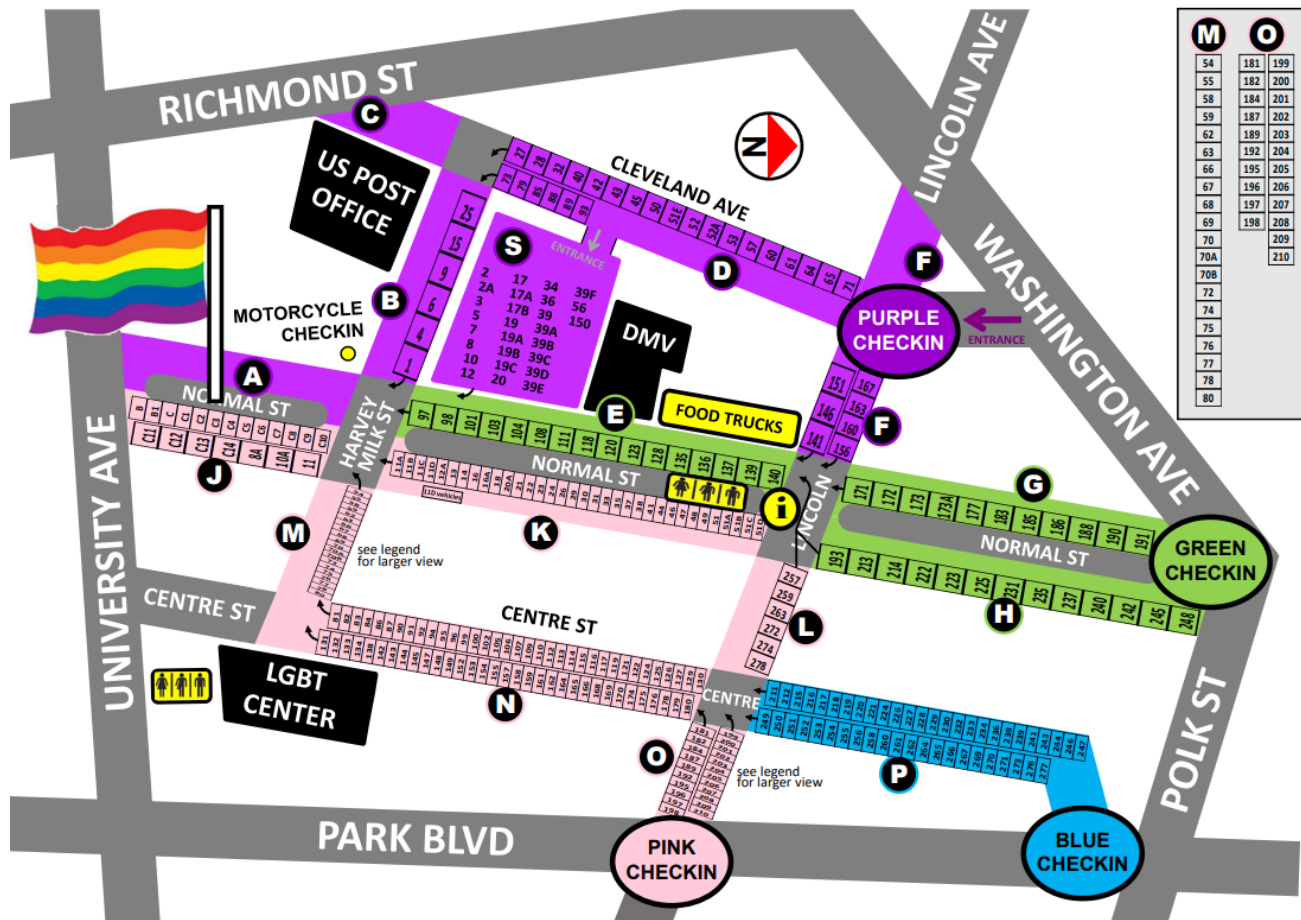
Service (USPS) postmarked) before or on the final date of the appeal.

2. 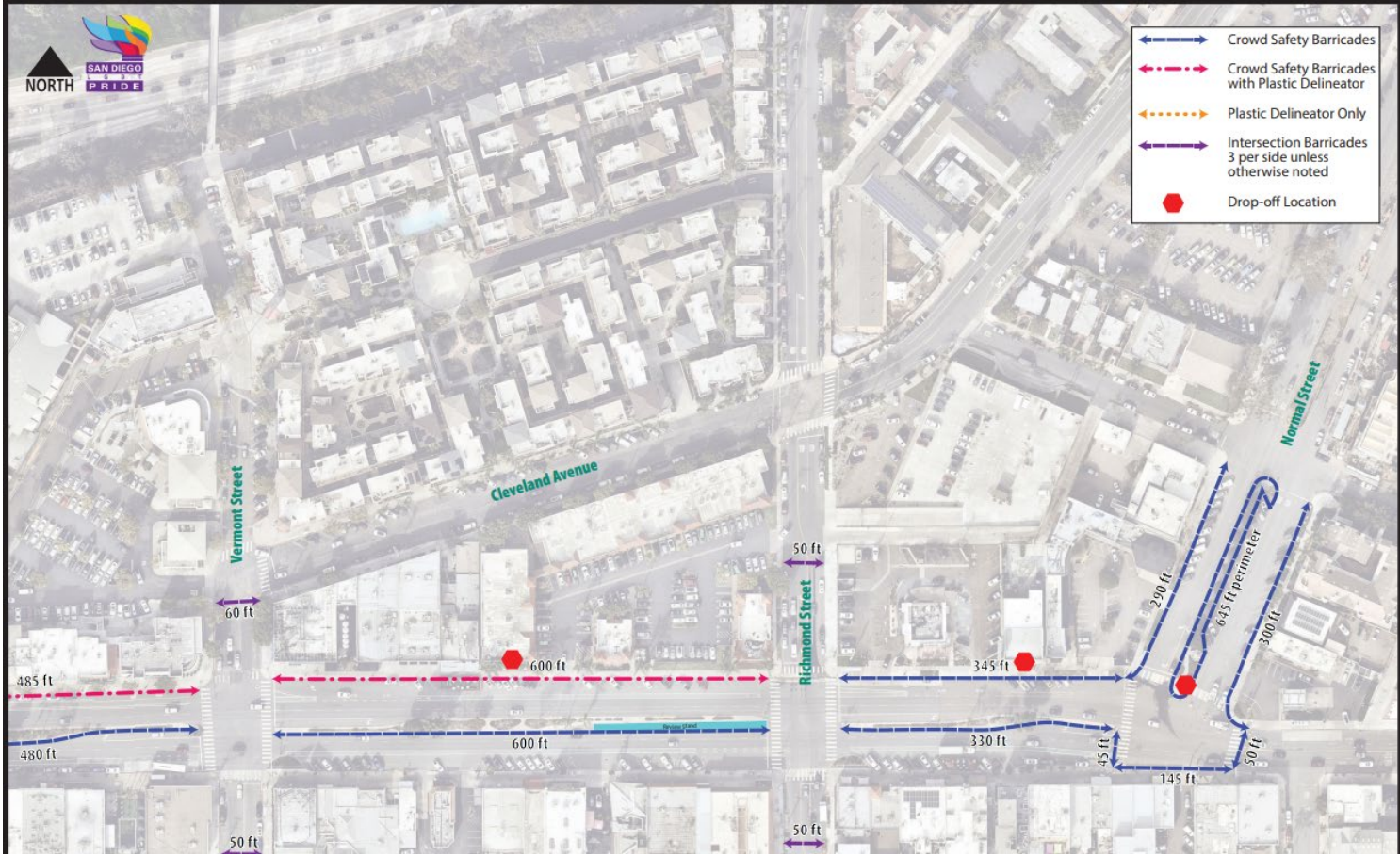
