PUBLIC SERVICE ANNOUNCEMENT REGARDING MEETING ACCESS

HOW TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the "Raise Your Hand" button on your computer, tablet, or Smartphone, or by

dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item.

When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first.

Those participating virtually may NOT cede time to others participating in person or virtually.

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be submitted the business day prior to the meeting to be distributed to the Hearing Officer and posted online with the meeting materials. All webform comments are limited to 200 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Please go to the Hearing Officer [website](#) for further instructions.

Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 1222 First Avenue, MS 501 San Diego, CA 92101. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Please Note: Documents related to the Hearing Officer meeting agenda items which are distributed to the Hearing Officer prior to the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 1st Floor, San Diego, CA. 92101.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 1222 First Avenue, 3rd Floor, San Diego, CA. 92101. ITEM 1: 4010 SORRENTO VALLEY BOULEVARD – PROJECT NO. 1062427**Staff:** Francisco Mendoza**City Council District:** 1**Plan Area:** Torrey Pines

Site Development Permit, Neighborhood Development Permit and Coastal Development Permit to demolish existing structures and construct two life-sciences (research and development) buildings totaling 380,000 square feet and construct a five-story parking structure. The 18.23-acre project site is located at 4010 Sorrento Valley Blvd in the IL-3-1 Zone, the Airport Safety Zone (Accident Potential Zone II - MCAS Miramar), the Special Flood Hazard Area, the Coastal Overlay Zone (Non-Appealable 1, and Coastal Appealable), and the Multiple Species Habitat Planning Area within the Torrey Pines Community Plan. The project is consistent with the Torrey Pines Community Plan Update (TPCPU) Environmental Impact Report (EIR) DEP No. 92-0126 (SCH No. 1992041021) and no additional environmental document is required under the California Environmental Quality Act. ITEM 2: CAMINO MAQUILADORA – PROJECT NO. 1099198**Staff:** Christian Hoppe**City Council District:** 8**Plan Area:** Otay Mesa

Easement Vacation to vacate a sewer and utility easement and a Site Development Permit for a new 169,500-square-foot warehouse with approximately 4,000 square-feet of office space, 4,000 square- feet of mezzanine space, and 177 parking spaces. The 8.2-acre site is in the IBT-1-1 zone, Airport Land Use Compatibility Overlay Zone (Brown Field), Airport Influence Area (Review Area 1), Airport FAA Part 77 Noticing Area (531-541 AMSL), Airport Safety Zone (Brown Field Zone 6), Community Plan Implementation Overlay Zone (Type A), Brush Management Zone, Very High Fire Hazard Severity Zone, Prime Industrial Lands, and the Transit Priority Area in the Otay Mesa Community Plan. This project was determined to be categorically exempt pursuant to Section 15183 evaluation of the California Environmental Quality Act. [Report No. HO-24-028](#).
