ITEM #2 <u>Mobility Master Plan:</u>

- **a.** Approve February and March 2024 Meeting Minutes: Motion made June Smith/Sujata Yellaepeddi to approve the February 2024 minutes. Motion passed 10-0-3 with Rebecca Rapp, Steve Dow and Alfredo Ortiz abstaining as they were not present, and Alfredo was not a member yet.
 - Motion made Ben Wier/Keith Mikas to approve the March 2024 minutes. Motion passed 6-0-7. Rebecca Rapp, Steve Dow, Steve Gallant, Hugh Rothman and Sujata Yellaepeddi were not present. Alfredo Ortiz abstained as he was not a member yet.
- **b.** Approve Treasurer's Report: Gary Long informed us we have \$322.95 in our account and \$73.63 (with \$48.49 outstanding) in the City funds. Motion made Gary Long/Steve Gallant to accept the report. Motion passed unanimously, 13-0-0.
- c. Ben Wier announced our website can fall under his business to help reduced our expenses.

ITEM #10 <u>Draft Environmental Justice Element of the City's General Plan</u> Voting Item

Environmental Justice is a new element to be added to the General Plan by the City of San Diego.

The purpose of the element is to advance the equitable distribution of benefits and limit environmental burdens in the City to promote healthy and livable communities for all San Diegans. The Regional Issues Committee will present proposed comments for the Board to forward to the Planning Department and Planning Commission regarding the proposals included in the draft document, as well as comments related to the limited time (only 30 days) provided by the City for review and comment on the draft plan. The Blueprint San Diego document and accompanying Draft Environmental Impact Report (DEIR) were also provided for review and comment bye the Planning Department. Blueprint SD is a proactive effort by the City to create an equitable and sustainable framework for growth to support current and future San Diegans. The proposal will be used to refresh the General Plan. All comments on the Plan and DEIR are due by April 29, 2024.
