  - i. The Mid-City Community Parking District is requesting that the City of San Diego allow owners and tenants to park in front of their own driveways. This would help provide relief in parking impacted areas at almost no cost to the City. It essentially creates a guaranteed on-street parking space in front of their driveway, while not taking a space from anyone else. In addition to the California Vehicle Code allowing this, it has already been done in a number of other California cities.
