Since enacting Citywide development impact fees, the City has not updated the previously adopted neighborhood PFFPs. However, they hope to update the Citywide Transportation Nexus Study in the next few years. When that happens, the City has offered to meet with the Otay Mesa Community Planning Group to discuss priority projects and other infrastructure needs.
