# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Event Permit - 17th Annual Bike The Bay

**COMMUNITY PLAN AREA:** Downtown, Barrio Logan, Otay Mesa-Nestor

**COUNCIL DISTRICT:** 3, 8

**LOCATION:** Marina Park Way/Convention Way, Harbor Drive, Beardsley St, National Ave, Otay Valley Regional Park

**PROJECT DESCRIPTION:** Special Event Permit for that portion of the Bike the Bay 25-mile event that would occur within the City of San Diego's right-of-way jurisdiction on August 25, 2024. The event route would follow Bayshore Bikeway through cities of San Diego, Coronado, Imperial Beach, Chula Vista and National City. The start and finish would take place at Embarcadero Marina Park South (Permitted through Port of San Diego). The event would include a fenced-in beer garden, and entertainment at the Embarcadero Marina Park South (port jurisdiction), onsite food preparation, food trucks, alcohol, tents/canopies, tables, chairs, a fenced in beer garden, sound amplification, portable restrooms, recycle/trash containers, and bicycling on city roadways. Noise associated with the event activities and set-up/dismantling would occur from 9 AM on August 24, 2024, until 2:30 PM on August 25, 2024. Set-up would occur from 9 AM until 2 PM on August 24, 2024, the event would occur on August 25, 2024, from 6 AM until 1:30 PM, and dismantling would occur from 12 PM until 2:30 PM. The number of attendees anticipated would be approximately 2500. The portion of the cycling event that would occur on city roadways and right of way would include Marina Park Way/Convention Way, Harbor Drive, Beardsley St, National Ave, along with an optional offroad route that would take place in the Otay Valley Regional Park (see route maps attached).

Road closures associated with this event would be as follows:

On August 25, 2024, from 6 AM until 1 PM.

Lane of Convention Way and Park Blvd from Harbor Drive to Embarcadero Marina Park South (200 Park Blvd.)

Lane of SB Harbor Dive from Park Blvd to C. Chavez (or alternate St.)

Lane of EB C. Chavez to National Ave.

Lane of SB National Ave. to SR-75 (San Diego-Coronado Bay Bridge)

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311

(Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

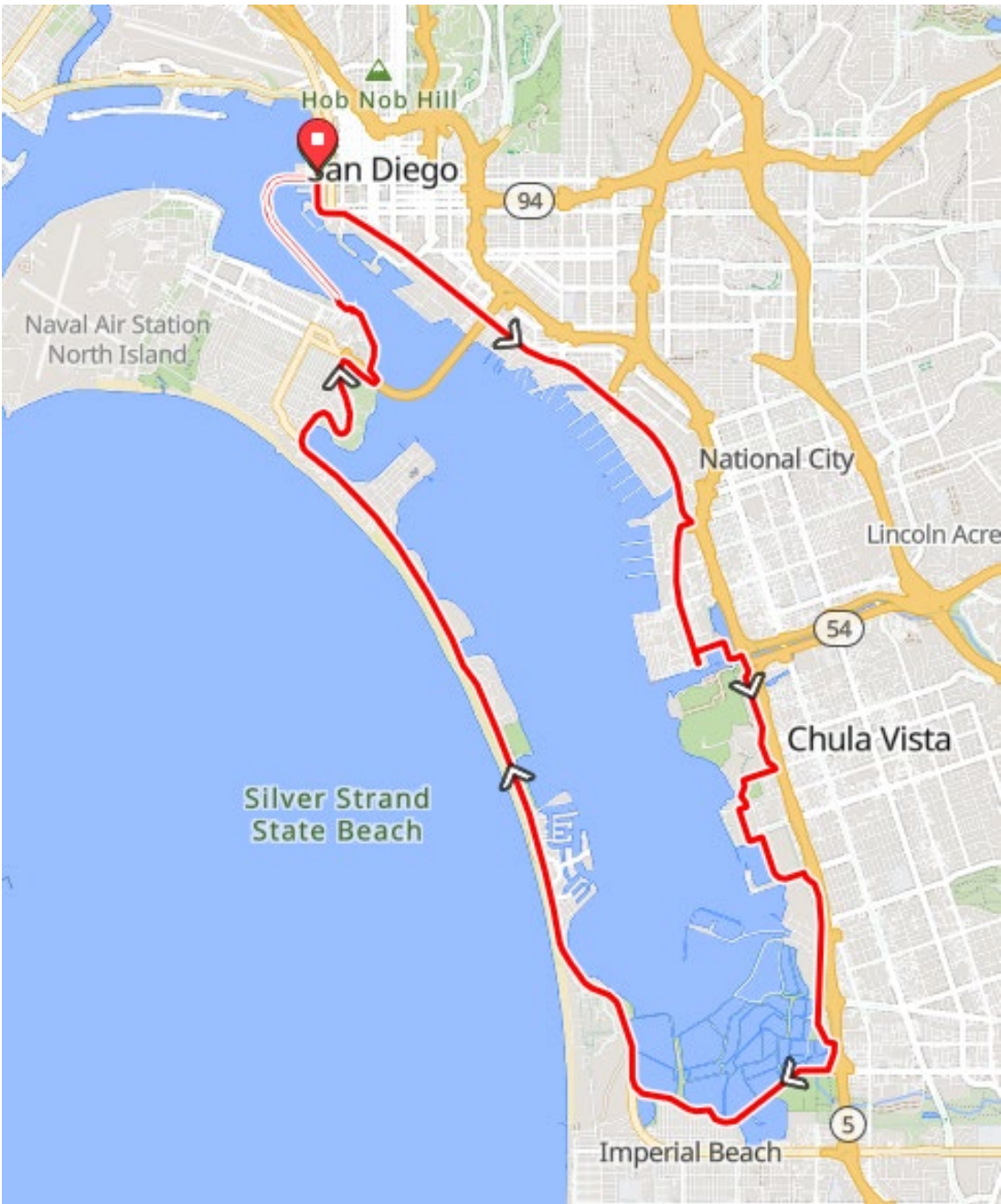
Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (**August 9, 2024**). Appeals to the City Clerk must be filed via email or in-person as follows:

1. Send the completed appeal form (including grounds for appeal and supporting documentation in pdf format) by email to [Hearings1@sandiego.gov](mailto:Hearings1@sandiego.gov) by 5:00p.m. on the last day of the appeal period; your email appeal will be acknowledged within 24 business hours. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be United States Postal Service (USPS) postmarked) before or on the final date of the appeal.
2.
