The City in partnership with Root Policy Research, launched an in-depth and collaborative effort to consult with elected officials, City departments, community stakeholders, residents, and beneficiaries of entitlement programs to inform and develop the priorities and strategies contained within this five-year plan. Consultation strategies included the formation of community outreach partnerships with housing, service, and mental health providers; workforce developers; community advocates; and others. Partnership members informed their clients and program beneficiaries that an important planning process was being undertaken and encouraged active participation by beneficiaries. Community outreach partnerships were also forged with elected leaders, community planners, businesses, public agencies and departments (City and region) to spread the word about the Consolidated Planning process.

COMMUNITY FORUMS

Eight Consolidated Plan Community Forums were conducted to introduce the City's Five-Year Consolidated Plan and federal programs, and to solicit input from residents and workers in the City on the level of need for various types of improvements that can potentially be addressed by the Consolidated Plan. The forums were held primarily in low-to moderate-income communities and sought to obtain broad input from the City's diverse communities. To promote attendance at the forums, targeted social media posts were done to reach a broader audience. Also, press releases and television appearance were done to promote the events. A total of 144 individuals participated in the forums and provided feedback on what they considered as the housing, economic, and community development priorities within the City.

WHAT IS A “CONSOLIDATED PLAN?”

A Consolidated Plan is a planning document required by the U.S. Department of Housing and Urban Development (HUD)

It uses a combination of data and community outreach to determine the top housing needs, community development concerns, and gaps in supportive services for low and moderate income populations in cities and counties

The document is produced every 5 years as a condition of receiving housing and community development funding

We expect to go to public comment in spring 2024

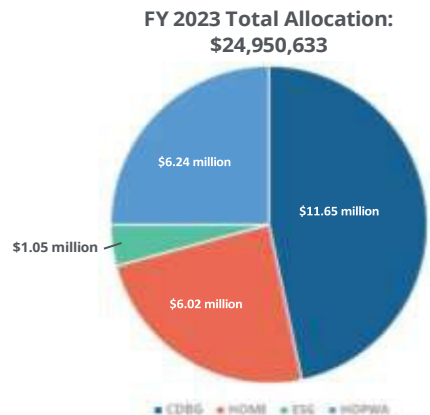

COMMUNITY NEEDS SURVEY

A Community Needs Survey was conducted to solicit input from residents and workers in the City of San Diego. Respondents were informed that the City was updating the Consolidated Plan for federal funds that primarily serve low- to moderate-income residents and areas. The questionnaire polled respondents about the level of need in their respective neighborhoods for various types of improvements that can potentially be addressed using entitlement funds. A total of 700 survey responses were collected in ten different languages: English, Spanish, Tagalog, Vietnamese, Mandarin (Simplified and Traditional), Somali, Pashto, Russian, Ukraine and Arabic. Hard copy surveys were also available in Haitian, Creole.

City of San Diego Asks Residents for Input on Ways to Invest \$135 Million in Federal Funds into Communities

NEW FIVE-YEAR CONSOLIDATED PLAN WILL GUIDE CITY'S FOCUS ON HOUSING, ECONOMIC DEVELOPMENT AND MORE

SAN DIEGO – The City of San Diego is asking for input on how to use \$135 million in federal funding to serve and invest in communities. San Diegans are invited to participate in a series of workshops and to take an online survey to help identify priorities as part of the City's Consolidated Plan, which is prepared every five years.

Goals identified in the five-year plan help guide the investment of funds from three federal funding streams: the Community Development Block Grant (CDBG) program, the HOME Investment Partnerships program (HOME) and the Emergency Solutions Grants program (ESG). The planning process is the framework for a community-wide discussion to identify housing, community development and economic development needs and priorities.

"We want the community's creative input as we move forward with making data-driven, place-based investment decisions, particularly for San Diego's communities of concern," said Christina Bibler, Director of the City's Economic Development Department (EDD). "This federal funding will allow the City to continue to deliver critical services in alignment with our communities' needs."

The City receives funding from the federal government each year to invest in low-and moderate-income communities. Funding can be used to increase access and availability of affordable housing, to improve sidewalks, parks and libraries, to provide services and shelters for those experiencing homelessness, for public services to support youth, seniors, veterans or other underserved groups, and for employment training and workforce development.

The new plan will cover FY 2025-2029, and community meetings will be held to determine how to spend federal funds to invest in San Diego communities.

To help with the planning, community members are invited to attend meetings and take an [online survey](#). Information gathered from the survey will help City staff identify the challenges affecting San Diego residents and their households now and potential solutions on how the City should address those issues.

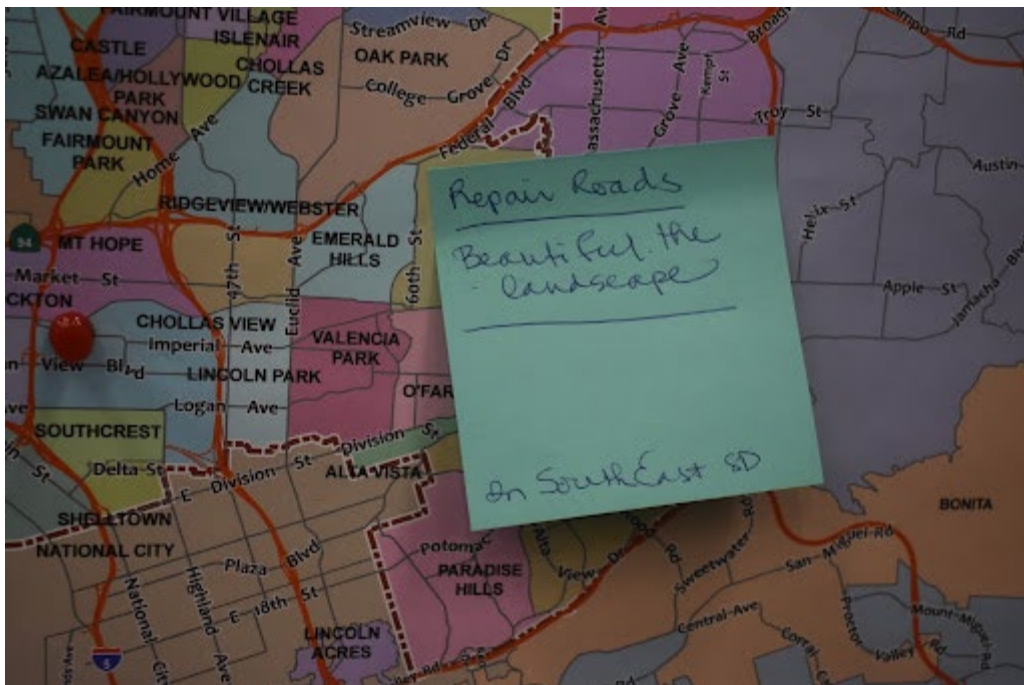

Residents and non-profit organizations of the community gathered Saturday to discuss their vision on how they would like to see \$135 million of federal Housing and Urban Development Funding (HUD) to be spent over the next five years.

Every five-years, the City of San Diego compiles a consolidated plan document to identify community needs and priorities. The consolidated plan is a combination of data and community outreach that determines top housing needs, community development concerns, and gaps in supportive services for low and moderate income populations.

For the 2025-2029 plan, San Diego's economic development team and city consultants engaged with residents and local nonprofit organizations, including the Black American Political Association's SD chapter, (BAPAC) in recent open forums.

Serving as the forums host, BAPAC's efforts work to ensure the economic, social, and political force of the Black community in San Diego remain relevant. Leading the Oct. 21 forum was David P. Dollahan of DPD solutions who serves as the city's five year plan consultant. In addition, Abena Bradford served as the moderator on behalf of BAPAC, whose nonprofit members were also in attendance to advocate for HUD funding to be prioritized for their community. Affordable housing, street-repair, homelessness, equity, job opportunities, and sustainability were some of the many topics brought up for funding allocation.

Bradford, who also serves as chair for the consolidated plan advisory board, spoke on the importance of non-profit collaborative efforts with government. "Nonprofits provide services to the community that the government sometimes can not reach. That's how important non-profits are, and that's why it is important we have an opportunity to make a contribution and let our voices be heard," said Bradford.

Dollahan broke down the four main funding sources within the \$135 million of HUD funds for the audience members to consider. These areas include the Community Development Block Grant, which is designed to improve low to moderate income communities. The Home investment Partnership Program, which regards affordable housing creation, the Emergency Solutions Grant, which targets getting people removed from homelessness. And lastly, the Housing Opportunities for Persons with AIDS program, which connects people's housing with medical social support services.

"These are the four preeminent housing programs that the community, I feel, gets to have a say in how the money is spent and where it goes," said Dollahan.

Although known for our sunny beaches and thriving economy, for years San Diego has been in the midst of a dual crisis as we grapple with both a housing shortage and a rising homelessness problem. While city leaders such as Councilmember Stephen Whitburn promised in 2020 campaign elections that "At the end of my term, there will be very few people left unsheltered in San Diego," the numbers tell a different story. In fact, between 2021 to 2022, homelessness rates rose by 22 percent.

informed in local government and nonprofit organizations—as these are the crucial areas where citizens can have the greatest impact on their community.

Meanwhile, other community members spoke on the premise of affordable housing. The city’s soaring housing costs, in combination with limited affordable options, have forced many residents out of their homes. In addition, waitlists for section-eight housing are incredibly long within the city. According to the San Diego Housing Commission, current waitlists are at approximately twelve years. Selecting funding prioritization into programs such as Home Investment Partnership Program can help streamline that process.

Furthermore, the forum also hosted a series of activities for attendees to participate in at the end to help the Economic Department solicit further input. In addition residents were also directed to fill out a survey that asked residents to rank service need priorities.

Residents and non-profit organizations of the community gathered Saturday to discuss their vision on how they would like to see \$135 million of federal Housing and Urban Development Funding (HUD) to be spent over the next five years.

Every five-years, the City of San Diego compiles a consolidated plan document to identify community needs and priorities. The consolidated plan is a combination of data and community outreach that determines top housing needs, community development concerns, and gaps in supportive services for low and moderate income populations.

For the 2025-2029 plan, San Diego's economic development team and city consultants engaged with residents and local nonprofit organizations, including the Black American Political Association's SD chapter, (BAPAC) in recent open forums.

Serving as the forums host, BAPAC's efforts work to ensure the economic, social, and political force of the Black community in San Diego remain relevant.

Leading the Oct. 21 forum was David P. Dollahan of DPD solutions who serves as the city's five year plan consultant. In addition, Abena Bradford served as the moderator on behalf of BAPAC, whose nonprofit members were also in attendance to advocate for HUD funding to be prioritized for their community. Affordable housing, street-repair, homelessness, equity, job opportunities, and sustainability were some of the many topics brought up for funding allocation. Bradford, who also serves as chair for the consolidated plan advisory board, spoke on the importance of non-profit collaborative efforts with government.

"Nonprofits provide services to the community that the government sometimes can not reach. That's how important non-profits are, and that's why it is important we have an opportunity to make a contribution and let our voices be heard," said Bradford.

Dollahan broke down the four main funding sources within the \$135 million of HUD funds for the audience members to consider. These areas include the Community Development Block Grant, which is designed to improve low to moderate income communities. San Diego Announces Series of Workshops for Public Input on Consolidated Plan

City officials asked for public input Wednesday on how \$135 million in federal funding for communities in the city should be spent, announcing a series of in-person workshops over the next several weeks.

San Diegans can also take an online survey at <https://www.research.net/r/sdconplan2023> to help identify priorities as part of the city's Consolidated Plan, which is prepared every five years.

“We want the community’s creative input as we move forward with making data-driven, place-based investment decisions, particularly for San Diego’s communities of concern,” Christina Bibler, director of the city’s Economic Development Department, said in a statement. “This federal funding will allow the city to continue to deliver critical services in alignment with our communities’ needs.”

The goals residents identify in the five-year plan can help guide funds from three federal sources: the Community Development Block Grant program, the HOME Investment Partnerships program and the Emergency Solutions Grants program.

San Diego receives funding from the federal government each year to invest in low- and moderate-income communities. Funding can be used to “increase access and availability of affordable housing, to improve sidewalks, parks and libraries, to provide services and shelters for those experiencing homelessness, for public services to support youth, seniors, veterans or other underserved groups, and for employment training and workforce development,” according to the city.

The new Consolidated Plan will cover fiscal years 2025-2029 and information gathered from the survey will help city staff identify the challenges affecting San Diego residents and their households, and potential solutions on how the city should address those issues.

Each year, the County's Housing and Community Development Services (HCDS) receives approximately \$14 million in federal entitlement funding from the U.S. Department of Housing and Urban Development. This funding is intended to provide increased affordable housing opportunities, support access to public services, and expand community infrastructure to create thriving communities. Every five years, HCDS creates what is referred to as the "**Consolidated Plan**".

What is the Consolidated Plan?

The Consolidated Plan is a document that serves as the County's official application for HUD entitlement funding. The Consolidated Plan is an evaluation of all housing and community development needs in the region, especially in the unincorporated County. The Consolidated Plan is a strategic 5-year plan for the four federal entitlement programs that are administered by HCDS. The Consolidated Plan helps to assess local affordable housing and community development needs and market conditions, to make data-driven, place-based investment decisions.

Based on community input and data collected, the 2025-2029 Consolidated Plan establishes 5-year goals and objectives for the approximately \$70 million in HUD funding the County will receive from July 1, 2025, through June 30, 2030. The County receives HUD funding through the following programs:

- [Community Development Block Grant \(CDBG\)\(External link\)](#): Supports communities by addressing local housing and community development needs.
- [HOME Investment Partnerships Program \(HOME\)\(External link\)](#): Primarily used to fund the development of affordable housing and rental assistance to lower-income households.
- [Emergency Solutions Grant \(ESG\)\(External link\)](#): Provides direct services to persons experiencing homelessness or at risk of homelessness.
- [Housing Opportunities for Persons With HIV/AIDS \(HOPWA\)\(External link\)](#): Provides housing and services to persons living with HIV/AIDS and their families.

Each year funding is allocated to eligible projects that work to improve the lives of San Diego residents and under-resourced communities throughout the region through a grant process, carried out through Annual Action Plans. HCDS creates the Annual Plan which includes the Strategy, Consolidated Plan goals, and a summary of actions, activities, and the specific federal funding used to address the identified needs. Planned activities are tied to the 5-year goals and objectives of the Consolidated Plan

How would you prioritize this money in your community?

Receiving community input is vital in determining County of San Diego community development and housing needs, as well as developing the 5-year goals for the 2025-2029 Consolidated Plan.

Funding can be used for community infrastructure, affordable housing, homelessness services and shelters, and public services. Previous projects include the construction of new sidewalks and accessible ramps, the development of neighborhood parks, and supportive services such as food assistance.



SUBJECT: FY 2025 – FY 2029 Consolidated Plan for HUD Entitlement Programs

The Economic Development Department is requesting your input regarding the budget priorities for the new five-year (FY 2025 –FY 2029) Consolidated Plan for HUD entitlement programs.

Background

The City of San Diego receives federal entitlement funds from the U.S. Department of Housing and Urban Development (HUD) to invest in local communities. The Consolidated Plan is a document required by HUD. The Consolidated Plan describes the strategies the City will pursue to address priority community needs, identifies objectives to measure progress, and guides investment of the HUD entitlement funds.

The City currently receives four HUD-funded federal entitlement program grants. These grants are addressed in the City of San Diego's existing Consolidated Plan and are listed below:

1. Community Development Block Grant (CDBG): The primary objective of the CDBG program is the development of viable urban communities through the provision of improved living environments, expansion of economic opportunity and decent housing. Grant funds are intended to serve "persons of low and moderate income" (LMI) as defined by HUD.
2. HOME Investment Partnerships Program (HOME): The HOME program is dedicated to the establishment and expansion of affordable housing for low-income households.
3. Emergency Solutions Grants (ESG): The purpose of the ESG program is to assist individuals and families regain housing (temporary and permanent) after experiencing a housing crisis or homelessness.
4. Housing Opportunities for Persons with AIDS (HOPWA): HOPWA funds may be used for a wide range of housing, social services, program planning, and development costs for the benefit of individuals living with HIV/AIDS and their families.

In July 2020, the County of San Diego was designated as the City of San Diego's alternative grantee for the HOPWA program. This alternative grantee designation ends on June 30, 2024, and may be extended for a one-year term through June 30, 2025, upon City Council approval.

Staff will present a request for this extension for Council's consideration along with the FY 2025 Annual Action plan in the spring of 2024.

The following **FY 2025 - FY 2029 Consolidated Plan goals were approved by Council Resolution #R-315265 effective December 22, 2023:**

GOAL 1: Increase, protect and preserve affordable rental and homeownership housing opportunities to improve access to a diverse set of affordable housing, accessible in design and energy efficient, and with proximity to job centers, schools, parks, and services.

GOAL 2: Invest in inclusive economic growth initiatives that develop and strengthen small businesses, support local entrepreneurs, expand employment and workforce development programs, and improve access to job opportunities.

GOAL 3: Develop vibrant, equitable, and adaptable neighborhoods by investing in public facilities, critical infrastructure, and nonprofit facilities that provide increased accessibility, resiliency, and sustainability.

GOAL 4: Improve housing stability for individuals and households with critical needs, including persons experiencing or at-risk of homelessness by providing appropriate housing and service solutions grounded in best practices.

GOAL 5: Improve community services by addressing critical needs and promoting equity through improved or increased access to community programming.

The approved Consolidated Plan goals will provide a framework for the ongoing development of the Consolidated Plan from which strategic objectives, budgetary priorities and action items can be further defined to advance the adopted goals. It is anticipated that a draft of the FY 2025 - FY 2029 Consolidated Plan will be available to the public and Consolidated Plan Advisory Board (CPAB) for review and comment in April 2024.

The Consolidated Plan Update Process

The Consolidated Planning process is a collaborative one with ample opportunity for community engagement and input. It is especially important for the City to solicit feedback from low- and moderate-income beneficiaries of federal entitlement funded projects. City staff reached out to Council offices for assistance in publicizing these community engagement efforts.

The community participation and engagement process included the following:

Community survey. The survey was released on August 31, 2023, and closed on January 7, 2024. In addition to English, the survey was available in the following languages: Spanish, Tagalog, Arabic, Vietnamese, Somali, Dari, Pashto, Korean, Chinese (Simplified and Traditional), Ukrainian, and Russian. A hard copy of the survey was also available in English, Spanish, and Haitian Creole.

Community forums. The City of San Diego hosted eight (8) public forums in October 2023 throughout the city to gather feedback on housing, community development, public service, and economic development needs and outcomes (see table below). For

each public forum, Consolidated Plan consultants, Root Policy and DPD Solutions, provided an overview of the Consolidated Plan planning process, what/how much federal resources the City receives, and other ways for the community to engage throughout the process. Following the presentation, consultants and staff facilitated three activities that had participants:

- Identify their most critical housing, community development, public service, and economic development needs;
- Prioritize outcomes with fixed resources among those identified needs; and
- Identify geographic preferences where those outcomes should be prioritized.

Spanish interpretation was requested and provided at the public forums in Linda Vista, Logan Heights, and San Ysidro. Vietnamese interpretation was requested and provided at the Linda Vista forum. In the public forum promotional materials, the City requested disability-related accommodations and interpretation requests be made five days prior to each forum.



Council District 9

Thank you for the opportunity to share our office’s FY 2025-2029 Consolidated Plan budget priorities. While the list of priorities below reflects the needs throughout Council District 9, it is critical that we focus our budgetary efforts on the communities most impacted by recent flooding. The needs in these neighborhoods have long been ignored by the City, and disasters both expose and deepen longstanding economic and social injustices.

Disaster recovery and relief

To the greatest extent possible, HUD entitlement dollars should support relief and recovery from recent storms and subsequent flooding. This can include direct assistance, grants to businesses and nonprofits, home rehabilitation, and infrastructure investments to prevent future crises.

Real property acquisition

HUD entitlement dollars should be leveraged to purchase real property to support our housing and infrastructure goals. The City has understandably been focused on selling or leasing publicly owned property to support our housing goals, but we should also consider how adding to our real estate portfolio can support our strategic goals. Such investments could support land banks and community land trusts.

Affordable housing development

The City has recently made it a priority to add shelter capacity, but we should not lose focus on what ends and prevents homelessness—an affordable home. HUD entitlement dollars should be leveraged to the greatest extent possible to develop affordable housing. This could include social housing pilot programs.

Implement Complete Streets Council Policy

Many jurisdictions use HUD entitlement funds to repair and repave roads, using a metric of how many low-to-moderate income residents use or live near a given road. Simply repaving a road may have made sense under a previous planning paradigm, but in an era of climate change and when streets are becoming more and more unsafe, we must think about our roads differently. Late last year, the City Council passed a Complete Street Council Policy. It would be unacceptable if HUD entitlement dollars were used on roads and streets and the resulting road treatment does not comply with the Council Policy.

Career and employment opportunities for youth, justice-involved San Diegans, and other disadvantaged workers

HUD entitlement funds should be used to support programs and organizations that connect San Diegans to career and employment opportunities. This should include supporting the implementation of the City's Youth and Child Master Plan.

SUBJECT: District 6 Budget Priorities for FY 2025 – FY 2029 Consolidated Plan for HUD Entitlement Programs

Thank you for the opportunity to submit my recommendations regarding budget priorities for the five-year fiscal year (FY) 2025 – FY 2029 Consolidated Plan for HUD entitlement programs, which include the Community Development Block Grant Program (CDBG), the HOME Investment Partnerships Program (HOME), the Emergency Solutions Grants Program (ESG), and the Housing Opportunities for Persons with AIDS Program (HOPWA). I am committed to working closely with my Council colleagues, the Mayor, City staff, and members of the public to balance and address the needs of our communities.

District 6 is home to Census Tract 85:11, a community of concern that contains the Convoy District and a portion of Kearny Mesa. The Convoy District serves as a nexus for both Pan-Asian businesses and the Asian American Pacific Islander Community that provides a dynamic cultural and economic hub for the City of San Diego. The Kearny Mesa Community Plan, which was adopted in 2020, further shapes the vision of urban villages and pedestrian-oriented design that will reflect the district's unique neighborhoods while still maintaining the needs of being one of the region's largest job centers. Further, in 2022, the San Diego City Council approved the Mira Mesa Community Plan, which added a housing capacity of 31,900 units, totaling the horizon of 58,700 units by 2050¹. The City's Consolidated Plan for HUD entitlement programs will help

bring this vision come to life, specifically in identifying housing, economic, and community development needs and priorities.

I recommend the following budget priorities related to HUD entitlement programs:

Affordable Housing

CDBG and HOME fund investments should go towards building more affordable housing and providing individuals and families increased access to affordable housing in the City. This includes the funding towards the development of affordable housing, rehabilitation, and land acquisitions. In addition, HOPWA funding should continue to prioritize housing opportunities and support services for individuals living with HIV/AIDS.

Homelessness and Supportive Services

CDBG and ESG investments should be prioritized towards aiding the City's goals to reduce and prevent homelessness. This includes funding for rehabilitation projects, transitional housing, homeless shelter and services for individuals and families experiencing homelessness, and homeless facility acquisition.

Economic Development

CDBG investment should be prioritized for small and minority-owned businesses. This includes increasing access to loans and grants for small businesses and neighborhood business improvements. Funding towards this will help expand inclusive economic growth and contribute to the enhancement of vibrant communities.

Nonprofit Support

CDBG funding towards the support for small and emerging nonprofits and nonprofit facility improvements will allow organizations to thrive and better administer programs that assist vulnerable populations, businesses, and improve community outreach.

City Projects

CDBG funding towards investment in park improvements, sidewalks, streetlights, and community facilities will also contribute towards the City's goals of creating more vibrant communities.

Community Engagement Process

This document updates outlines the community engagement elements planned for the City of San Diego's 2025-29 Consolidated Plan. The Community Engagement Plan is a framework to guide the community engagement process, including goals and content, logistics, outreach, and promotions for the Consolidated Plan update. This is a living document which will be adapted over the course of the project, beginning with the scope of work Root Policy provided in our proposal, and refined in consultation with the Consolidated Plan team.

Community Engagement Elements

Following is a list of the community engagement elements described in Root Policy's scope of work in the initial proposal. Outreach would focus on typically under-represented and underserved groups, including but not limited to low-to-moderate income persons, racial/ethnic minorities, persons living with disabilities, domestic violence survivors, and persons with potential barriers to participation (e.g., difficult work schedules, language barriers).

- Citizen Participation Plan review;
- Public forums;
- Stakeholder engagement and consultations;
- Consultations
- Community survey; and
- Public hearings.

Citizen Participation Plan review. The City of San Diego updated its Citizen Participation Plan in May 2020. Root and DPD Solutions have reviewed the City's CPP and have no substantive feedback.

Public forums. Root will conduct eight (8) public forums (seven (7) in-person forums and one online forum) with low- and moderate-income residents and special needs populations to collect information on their housing, service and economic needs and challenges. In-person meetings will be held in the following areas:

- **Linda Vista** | Wednesday, October 4th from 6-7:30 p.m. at Bayside Community Center
- **City Heights** | Monday, October 2nd from 6-7:30 p.m. at City Heights Library

- **Valencia Park** | Date TBD
- **Skyline** | Tuesday, October 3rd from 5:30-7 p.m. at Skyline Library
- **Downtown** | Date TBD
- **Mountain View** | Saturday, October 21st from 12:00 – 2:00pm at Educational Cultural Complex

The online public forum kickoff meeting will be held on Thursday, August 17th from 11a.m. to noon. Root will provide Spanish interpretation at the online public forum. Root will work with City staff to identify which interpreters will need to attend the other specific public forums. Root will work with City staff to confirm the presentation and activities for each of the public forums. Root staff would facilitate the groups and provide notes and summary findings to City staff. Root maintains a strong focus group guide and findings template to summarize the discussions, which we would provide to the City for internal use.

Root has sent the City a memo detailing proposed activities for the public forum.

Stakeholder engagement and consultation. For stakeholders that did not attend the August 17th online public forum, Root will work with City staff to identify and conduct interviews with organizations/stakeholders that should be consulted, such as public and nonprofit agencies that provide health and human services, assist special needs populations, develop and manage affordable/subsidized housing, and coordinate homeless services. Root can also include adjacent units of government and agencies receiving HUD funds. Stakeholder interviews will be held virtually; however, if there are specific stakeholders that the City would like for us to meet in-person during the weeks that we are present for the in-person public forums (e.g., Councilmembers), we are happy to accommodate those requests.

Community needs survey . Root will coordinate with the City of San Diego Con Plan team on developing a community needs survey to help the development of the Consolidated Plan. Proposed content of the community survey will include stakeholders' perspectives on the most critical housing, community development, public service, and economic development needs in the city and what outcomes stakeholders would like to see as a result of the City's HUD funding.

Currently, Root anticipates the survey to go live in **mid-to-late August 2023**, closing in **early January 2024**.

Outreach and promotion: Root proposes sending out promotional materials a week before the survey is set to launch.

- Mainstream media relations—**press release distribution by the Con Plan team.** Root Policy has provided draft content.
- **Jurisdiction website promotion.** Root Policy has provided draft text.
- **Jurisdiction social media.** Root Policy has provided sample posts.
- **Emails to stakeholders for distribution.** Root Policy has provided draft text.
- **Distribution of printed flyers throughout San Diego in high visibility locations**—libraries, recreation centers, waiting areas at City Hall and locations that provide direct resident services (e.g., permits, licenses, bill pay, ticket payment, information booths). Root Policy has provided a draft flyer and will finalize it after City staff feedback. Once finalized, the flyers will be available in languages specified by the City of San Diego Con Plan team.

Community meetings and public hearing s. HUD requires two public hearings to be held during the Consolidated Plan update process—one during the development of the plan and the other during the public comment period. The first set of public hearings will address housing and community development needs, community engagement findings, and draft Consolidated Plan goals, while the public hearings in spring 2024 will provide the public the opportunity to comment on the draft Consolidated Plan and Annual Action Plan. Root will also plan to meet with the Consolidated Plan Advisory Board (CPAB) during the development of the plan and before the draft plans go to public comment. A table of proposed meetings and public hearings is provided at the end of this document.

Report Section

Once the survey is closed, we will provide a standalone section for the City, segmented by respondent type and, for residents, key demographic characteristics. We will also include primary findings from the stakeholder consultation and community meetings in the section. This section will be designed to be appended to the Consolidated Plan in IDIS and also easily lifted into the "PR" sections of the eCon Plan.
