# San Diego Lifeguard Service

Brian Clark announced full staffing and increased staff hours for the long 4<sup>th</sup> of July weekend. Lifeguards are preparing to the large crowds expected. Upcoming special events include OTL World Championships on July 13/14 & 20/21, with PIFA, BayFair and MB Music Festival in September. Mike welcomed Steve Pinard as the newly appointed member, replacing Darlene Walter at the August meeting as the non-hotel Lessee rep. Mike announced that Deputy Director Christina Chadwick as accepted the position of Executive Director for Special Events, beginning her new role on July 8<sup>th</sup>, Mayra Medel will be the Interim Deputy Director for Mission Bay/Shoreline Parks Division. Special Fireworks shows will occur on July 3<sup>rd</sup> and July 4<sup>th</sup> launching from Fiesta Island. Look for new illegal fire signs at Crown Point Shores and some beach areas
