PROJECT NAME: Howard Avenue (Park Blvd. to Oregon St.) Phase I-II Road Improvements UU71-72

COMMUNITY PLAN AREA: North Park

COUNCIL DISTRICT: 3

LOCATION: Work will occur on developed City right-of-way and City easements at the following locations: Howard Avenue, Park Boulevard, Georgia Street, Florida Street, Alabama Street, Louisiana Street, Texas Street, Arizona Street, Hamilton Street, Oregon Street, and north-to-south midblock alleyways bounded by Park Boulevard to the west and Oregon Street to the east.

PROJECT DESCRIPTION: The project proposes streetscape improvements such as the installation of new curb ramps and alley aprons and street resurfacing, including, but not limited to, concrete pavement replacement, asphalt pavement repair, and base pavement repair.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: This activity is categorically exempt from CEQA pursuant to CEQA State Guidelines, Section 15301(c) (Existing Facilities); 15302(c) (Replacement or Reconstruction); 15303(d) (New Construction or Conversion of Small Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Engineering & Capital Projects Department

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review which determined that the project meets the categorical exemption criteria set forth in the following CEQA State Guidelines: Section 15301(c) (Existing Facilities), which allows for the maintenance or minor alteration of existing public facilities involving negligible or no expansion of existing or former use, such as the resurfacing of existing roadways including base pavement repair; Section 15302(c) (Replacement or Reconstruction), which allows for replacement of existing facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced, such as the replacement of Small Structures),

which allows for the construction and location of limited numbers of new, small facilities or structures, such as the installation of new curb ramps and alley aprons; and where the exceptions listed in Section 15300.2 would not apply.

Appeals to the City Clerk must be filed by email or in person as follows:

The appeal filing fee must be United States Postal Service (USPS) postmarked within five (5) business days of the date the appeal is filed.
