Resident Brad is concerned with the approved stop sign at Keir and Larkin. His concern is the community was not contacted in any manner. The 2 traffic studies in the past are questionable as to the points taken.

Resident Lorenzo lives on Murray Ridge and has been a residen since 1969. His concerns are the bike lanes being safe for all of our community, increased crime in the area, and increased costs with taxes and other charges we keep having to absorb as residents of Serra Mesa.

A resident has conerrns over the crosswalk at Greyling and Sandrock.

Kathleen Lippitt has concerns over the budget cuts and the lack of oversite on the smoke shops across the city and would like the community to report any illegal actions of all smoke shops.

## **Information and Action items:**

- 1 Info Item: Stephanie Green of SD Parks & Rec along with John Stokes of SDUSD present the Jones Elementary Joint Use Park Facility Workshop. The Park will be completed along with the school site modernization in 2028. The community input was more trees are requested for the site. The request for synthetic turf was rejected cuase of the cost of maintaining it and the heat factor. Other questions were regarding ample parking and entrances into the park. The plan will be brought to the planning group for approval as an Action Item on July 18, 2024.
- 2 Into Item: Rich Gustafson from Citymark attended via Zoom to answer questions on the new development projects on Mission Village Dr. 2696 MV Dr will be finished in June of 2025, 3222 MV Dr to be finished in August of 2025, and 3241 MV Dr will be finished in January of 2026. Questions on parking spaces and other details were not available at this time. All new residencies will not have any affordable options as that has been moved to another development in Bankers Hill.
